<p>LEGAL BASIS FOR THE PROCESSING</p> 	<p>The legal basis for processing of your personal data as indicated in the above row depends on the purpose for which the personal data is processed, it might be either:</p> <ul style="list-style-type: none"> (a) necessity to enter into a contract with you or to take steps at your request prior to entering into a contract, (b) our legitimate interest in establishing business relationships, conducting negotiations, performing contracts, executing settlements, client acquisition, brand awareness, managing client relationships, developing sales, improving sales management, maintaining contact with you, performing our administrative tasks, translation services, occasional gifts delivery, (c) our legitimate interest in legal and compliance obligations, such as preventing fraud, facilitating incident response, and preventing cyber attacks, or (d) our legal obligation to process your personal data stems from generally applicable laws.
<p>RECIPIENTS OF PERSONAL DATA</p> 	<p>RTB House may disclose your personal data to:</p> <ul style="list-style-type: none"> • RTB House associates, • subcontractors, where necessary, • other companies within the RTB House corporate group for administrative purposes, • law enforcement agencies, supervisory authorities, or courts when required by law.
<p>TRANSFERS TO OTHER COUNTRIES</p> 	<p>RTB House will not transfer your personal data outside of the EEA unless necessary measures are taken to ensure compliance with applicable laws. These measures may include transferring data to a country deemed to provide adequate protection by the European Commission (Article 45 GDPR) or pursuant to Standard Contractual Clauses (Article 46 GDPR). You can obtain a copy of these clauses by contacting our DPO.</p>
<p>RETENTION PERIOD</p> 	<p>We will store your personal data for the period necessary to fulfill the purposes outlined above. Specifically:</p> <ul style="list-style-type: none"> • personal data for contract execution will be processed until potential claims are time-barred or until the retention period provided in the generally applicable laws, • personal data in accounting documents will be stored according to legal retention periods, and until claims are time-barred, • personal data processed for legitimate interests will be stored until an objection is made or the data's usefulness expires.

<p>DATA SUBJECT'S RIGHTS</p>  	<p>You have the right to know about the data processing we conduct and what personal data we have about you. If you would like to receive a copy of your personal data, we will provide such a copy for you.</p> <p>If your personal data is wrong or incorrect, you can tell us and we will fix it. Until that happens, you have the right to restrict the processing and it will be limited to storage only for that time.</p> <p>If you no longer wish to have your personal data processed you can also exercise your right to object or ask for its erasure. In certain situations we may still keep some of your personal data even after your request. <p>SOURCE OF PERSONAL DATA</p> 	<p>We obtain your data directly from you, your employer, contractors, or colleagues, from publicly available sources such as public registers, databases of entrepreneurs, professional networking platforms, scoring reports provided by our partners, or online tools like LinkedIn.</p>
<p>OBLIGATION TO DISCLOSE PERSONAL DATA</p> 	<p>Your personal data is required to enter into a contract or manage a business relationship with you or your company.</p> <p>In other cases, providing your personal data to us is voluntary but necessary for conducting marketing activities, business communications analysis and ensuring security and legal compliance by RTB House. If you don't provide us with your personal information, you may not be able to cooperate with us and the abovementioned purposes may not be reached.</p>
<p>AUTOMATED DECISION-MAKING</p> 	<p>We will not use your data for automated decision-making or profiling.</p>
