- Corporate governance frameworks have also been established across the Syrah Group to enhance the Company's overall performance and shareholder value⁽¹⁾







A holistic approach to Malaria mitigation

- Malaria mitigation is a core element of the Balama Health Program with preventative measures implemented across our workforce and in the Host Communities
- All mitigation efforts are consistent with the Mozambique National Malaria Control Program, and includes:
 - o Ultra-sensitive Rapid Diagnostic Testing of all camp residents on their immediate return from, or departure to, their Rostered Leave Period
 - Trapping and mapping of mosquito species focussing on the Anopheles mosquito which is the carrier of the Plasmodium Falciparum malaria strain
 - Regular and targeted indoor residual spraying based on trapping data indicating mosquito larvae breeding sites
 - o Workforce and community education campaigns including a strictly enforced camp dress code
 - o Insecticide treated bed nets in all camp accommodation with nets also donated to the Balama District Hospital
 - Regular hot and cold fogging in active work areas and in accommodation village

Strict protocols and measures implemented across the Syrah Group to combat COVID-19

- In January 2020, Syrah's Crisis and Emergency Management Teams ("C&EMT") were activated in a preventative manner to assess, manage and where possible, minimise the impact of Coronavirus ("COVID-19") on employees, the business and key stakeholders
- The World Health Organisation subsequently declared COVID-19 a global pandemic on 11 March 2020, and the Company had already implemented strict protocols and mitigation measures across the Group with comprehensive scenario planning undertaken for its Balama and Louisiana operations
- The health, wellbeing and safety of employees and contractors remains Syrah's highest priority and the Company firmly believes it is making the right decisions in conjunction with Government advice at a minimum, and further where we can, in order to mitigate the risk of COVID-19 transmission to our workplaces or the communities in which we operate
- Key measures implemented include:
 - The temporary suspension of production at the Balama Graphite Operation ("BGO") with several protocols in place for teams remaining onsite for the duration of the temporary suspension period including:
 - Restrictions on travel and onsite movements and limited interaction with the local community where possible
 - Fourteen day quarantine for all visitors deemed critical to supporting the operation and maintaining health & safety standards
 - Thorough accommodation village, site and vehicle cleaning, enforced social distancing and health and hygiene training
 - Protocols for all service providers / delivery vehicles with strict conditions of entry to site, temperature checks for all drivers and escalation procedures in place
 - The temporary suspension of operations at the Battery Anode Material ("BAM") facility in Louisiana
 - Syrah is continuing to working closely with suppliers, contractors and customers to assess what controls are being implemented to manage the impacts of COVID-19 and to provide support as required
 - The C&EMT continue to meet three times a week to assess and manage the impacts of COVID-19 on the Group
 - The Company remains vigilant with respect to the latest information on COVID-19 through credible sources and will continue to follow the advice of Governments in the jurisdictions in which we operate, and take more proactive measures if deemed necessary and in the best interests of our people



Temporary suspension of production at Balama necessary to ensure the health and safety of employees

- The Government of Mozambique declared a Level 3 State of Emergency on 1 April due to the COVID-19 pandemic
- The country has enacted additional measures in relation to the management of COVID-19 including inbound travel restrictions, mandating fourteen day self-quarantine for all international arrivals, suspending the issuance of official documents (e.g. visas and travel documents) and restrictions and mandatory quarantine measures for domestic travel
- The combination of these restrictions on international and domestic travel and the health risks associated with the virus itself has led the Company to suspend production at Balama temporarily
- Immediate actions have been implemented with the following considerations:
 - Maintaining the health and safety of employees, contractors and Host Communities
 - o Sustaining current ESG (Environmental, Social and Governance) performance
 - $\circ~$ Maintaining full health and emergency response capability onsite
 - Supporting Balama District, Cabo Delgado Province and Mozambique in general in containing the advancement of COVID-19
 - Maintaining strong and mutually beneficial relationships with Government and Community stakeholders
 - Preserving the long-term sustainability of the business, and of jobs where possible
 - o Implementing risk mitigation measures in line with Company Values
 - o Maintaining respectful relationships with our employees and contractors
 - o Ensuring ramp-up capability, subject to operating and market conditions




Temporary suspension of operations at Syrah's Battery Anode Material ("BAM") plant in Vidalia (Louisiana, USA)

- From 5:00pm on 23 March 2020, Louisiana's Governor enacted a state-wide "Stay at Home Order" including the limitation of operations or temporary closure of certain businesses, to protect the health and safety of the public, mitigate the impact of COVID-19 and disrupt the spread of the virus
- This means that only essential industries and services can remain open such as chemical manufacturing, medical centres, and grocery stores. Residents can only leave their homes to work in select essential industries and services, purchase food, access necessary nonelective medical assistance and exercise
- Even though Syrah's BAM operation is classified as an essential industry, the Company has temporarily suspended operations in Vidalia until 1 May 2020 in support of the Governor's public health objectives
- Further actions have been implemented at BAM including:
 - All BAM staff working from home reviewing, updating and developing safety, operating, and maintenance procedures in preparation for recommencing operations
 - Regular site inspections (observing social distancing protocols) to ensure safety of plant and equipment
 - Ongoing stakeholder engagement with local authorities including Town of Vidalia administration & utility management as well as local economic development officials
 - Donation of masks and other surplus personal protective equipment (PPE) to the local Merit Health System Hospital in Natchez, Mississippi


- The Mozambique Ministry of Land, Environmental & Rural Development (MITADER) has approved the Company's application to renew it's 5 year Environmental Licence
- The review and audit process focussed on the Company's Environmental performance and Environmental Management Plan which details how the Company will operate in an environmentally responsible and sustainable manner and considers both current and future mining activities
- During this review and audit process MITADER also approved the Environmental Safety Plan for the Balama Tailing Storage Facility
- An action plan is under development to implement additional measures in line with commitments made under the new Environmental Licence
- An independent audit of the revised Environmental Management Plan is planned for H2

Greenhouse Gas emissions reporting established at Balama

- Syrah acknowledges the Intergovernmental Panel on Climate Change (IPCC) assessment of climate change science, which has determined that the human influence on the climate system is clear, greenhouse gases are the highest in history and adaption and mitigation strategies are required to reduce risk and enable climate-resilient pathways to sustainable development
- Accordingly, the Company has commenced Scope 1 Greenhouse Gas emissions reporting at Balama to understand the Operation's emissions profile to identify and implement emissions reduction strategies where possible






Greenhouse Gas Emissions Scope 1 Reporting

Water stewardship drives reduction in raw water consumption

- Water for the Balama Graphite Operation is predominantly sourced from Chipembe Dam which has a capacity of approximately 25 million cubic meters
- Syrah's Water Licence permits 2 million cubic meters of water to be withdrawn from Chipembe Dam annually with current consumption rates well below 50% of licensed volumes
- Continued focus on reducing raw water consumption by implementing measures to improve recycled water usage at Balama



Cumulative Water Usage vs. Annual Licensed Volumes




Water Withdrawn from Chipembe Dam





Balama Tailings Storage Facility (TSF)


- Q1 continuous improvement activities included:
 - An independent expert external review of the Balama TSF and all associated management systems and processes was conducted in March with positive assessment of current operations and opportunities to further strengthen TSF protocols identified
 - TSF water level and quality assessment (ground and surface)
 - o Vibrating wire piezometers monitoring
 - o Minimise acidification by adding elevated doses of lime from thickener
 - o Continual run of evaporation system to improve TSF pond reduction
 - Liner maintenance along exposed walls of the TSF
 - Laboratory tests for tailings
 - TSF expansion works commenced on 14 April to provide future storage capacity from 2022
 - Alternative deposition methods under investigation to reduce environmental impact and reduce long term capital costs






Waste management practices focus on reuse and recycling where possible


- Non-hazardous and hazardous waste disposal methods closely monitored to drive continual improvement
- Monthly differences in waste disposal method (for both non-hazardous & hazardous waste) can be attributable, in part, to Balama's cyclical waste disposal strategy
 and contractor camp waste removal campaigns which are completed on an as required basis
- Various waste initiatives have been implemented to increase the reuse and recycling of waste produced on site including scrap wood donations to the local community Beekeeping Project, organic waste provided to local pig farmers, recycling and the substitution of single-use plastic water bottles where possible
- Plans in place to review Balama's waste disposal performance against industry peers using relevant sustainability disclosures / reporting frameworks



Hazardous Waste Disposal by Method (t)





Local Development Programs drive sustainable development

Livelihood Development Program⁽¹⁾

- The Livelihood Development Program (LDP) is an ongoing program operated in partnership with the Company's Host Communities to provide formal agricultural training to local farmers to improve their crop yields, promote food security and generate independent livelihoods separate from the mine
- The LDP continued as planned in Q1 with 21 demonstration plots established across eight Host Communities. These demonstration plots serve as training grounds for farmers to learn new and improved farming techniques to enhance their crop yields
- During the quarter approximately 120 farmers participated in in-field training on best agricultural practices delivered by the technical agriculture team from IIAM-Mapupulo and was also attended by the Director of the District Service of Economic Activities of Balama and his team (top right photo)
- The technologies disseminated and discussed during the training course covers crop care, push and pull techniques for corn crops, improved peanut cropping and the use of organic pesticides and fertilisers
- The farmers also learn about pesticides produced from leaves of plants such as Neem and Castor, both readily available in Balama
- The difference in growth between crops sown under disseminated technologies compared to traditional farmers' techniques is significant (bottom right photo depicts the comparison)

(1) The Livelihood Development Program is a local development initiative included under the Local Development Plan which has been endorsed and is governed by the Local Development Committee (LDC). The LDC consists of Company, Host Community, District and Provincial Government representatives, established to ensure fair and transparent stakeholder oversight / input into local development projects and associated expenditure.





Local Development Programs drive sustainable development

Pirira Primary School

- In 2019, the Local Development Committee approved the community's request to build two Primary Schools in the villages of Pirira and Muape in 2020 and 2021 respectively
- These local development programs will be delivered in accordance with the commitments outlined in the Company's Mining and Local Development Agreements with Government
- The contract for the construction of Pirira Primary School has now been awarded to local contractor, MAC Construções who started mobilising and preparing for casting of the first stone in February
- A Memorandum of Understanding for the Pirira Primary School has been established between Twigg and the Balama Government which defines the responsibilities of both Parties with regard to construction and ongoing operation of the school
- A ground-breaking ceremony to mark the official commencement of construction works in Pirira took place on the 4th of February attended by members of the Local Government including the District Permanent Secretary, Company representatives and community leaders
- Of the 34 workers currently employed on the construction project, 12 have been recruited from the Host Communities, of which 67% are graduates from the Balama Professional Training Centre
- As at the end of March, construction was approximately 20% complete, however COVID-19 restrictions will likely hinder further progress temporarily





Recognising international commemoration days promotes social inclusion

International Day of Forests

- International Day of Forests is commemorated on the 21st of March each year to raise awareness as to the importance of forests in maintaining and cultivating ecosystems, combating climate change and their crucial role in alleviating poverty
- To mark the occasion Syrah donated approximately 1,600 native seedlings cultivated at the Balama Nursery to its Host Communities to encourage environmental responsibility, promote the importance of preserving native flora & support reforestation in the local district



International Women's Day

- International Women's Day is celebrated on the 8th of March to recognise the contributions and achievements of women, build support for women's rights and eliminate discrimination against women worldwide
- Due to COVID-19 / social distancing protocols, this year Syrah commemorated the occasion by interviewing women across the workforce about their lives and work achievements and publishing their inspiring stories in a special edition of the monthly newsletter



Health campaigns and community engagement enable improved health and safety awareness

Health Campaigns

- Syrah partnered with the District Health Services, Women and Social Affairs to raise awareness on the serious health consequences associated with parasitic diseases caused by poor health and hygiene
- This initiative is part of a nationwide campaign to provide treatment for sufferers of Lymphatic Filariasis, Onchocerciasis and Intestinal Parasites; diseases which severely impact the health and livelihoods of local communities and can also lead to blindness in the case of Onchocerciasis
- The awareness campaign was successfully held on the 31st of January, attended by the District Health Services brigade, Company Health & Safety representatives, employees and an encouraging number of Host Community members



Mine Open Doors

- To commemorate International Women's Day, Syrah invited women working in the Education and Health sectors in the Balama District to attend the Company's 11th Edition of its Mine Open Doors Program
- The women received a guided tour of the mine and processing facility to understand the end-to-end process of turning ore into natural flake graphite, and the strict measures in place to ensure the safety of all personnel
- The visitors also had the opportunity to interact with female employees working in Mining, Maintenance and Processing departments to understand their experiences and learnings
- The women thoroughly enjoyed their visit and requested to return again in the near future




Stakeholder engagement is central to open communication and mutual benefit

- Q1 Government and other institutional stakeholder engagements were characterised by Government elections in Mozambique, the security situation in Cabo Delgado and the evolving COVID-19 situation
- The re-elected President Filipe Nyusi formed his Government Party with several changeouts of Cabinet Ministers. Importantly, the Minister of Mineral Resources and Energy remains the same, which enables the Company to further foster its already strong relationship with the Ministry
- President Nyusi has also introduced and elected Secretaries of State to represent the Central Government in each of Mozambique's ten Provinces. The Company was honoured to receive Cabo Delgado's appointed Secretary of State, Armindo Ngunga, at the Balama Graphite Operation on the 29th of February to understand more about Syrah's operations and sustainable development commitments
- Insurgent activity in northern Cabo Delgado continues to drive regular interactions with key diplomatic stakeholders including the Mozambique Government, Australian High Commission, the British High Commission and the US Embassy Security department
- Engagements with the Minister of Transport, Minister of Public Works and the National Administration of Roads (ANE)
- Several engagements with Government officials took place in March to share and discuss COVID-19 insights and inform key stakeholders of the measures Syrah is implementing to ensure the health and safety of employees, contractors and the wider community






Key employment metrics closely monitored




Local (Host Community) Employment



Training in Mandatory Competencies maintained at 100% completion

- Mandatory Training units of competency at the Balama Graphite Operation are General Induction, Business Conduct Training⁽¹⁾, Critical Hazard Management Standards, Occupational Exposures, Risk & Hazard Management, Fatigue Management, Human Rights and In-field Visible Leadership
- Completion of refresher training in Mandatory Competencies remains ongoing to ensure total compliance does not drop below 100% across Twigg and contractor groups
- Strong in field leadership and critical hazard management remain key training areas at Balama

Training and professional development remains a key focus at Balama

- Four employees (two Trainers, one Bagging Supervisor and one Forklift Operator) have successfully completed training to become nationally accredited training Assessors (top right photo)
