VET Credit in the VCE, including the VM and the VPC

The information below is from the VCAA website regarding VET credit in the VCE, VCE VM and the VPC.

VET in VCE, including the VM and the VPC

Students gain credit into their VCE, including the VM, and the VPC by undertaking:

- › **VCE VET programs** that have been developed by the VCAA in consultation with stakeholders including industry. Information regarding the VCE credit available in each VCE VET program is published on the individual VCE VET program pages on this website.
- › **Approved apprenticeships and traineeships** that are in the same industry areas as designated VCE VET programs.
- › Other VET qualifications, which provide credit into the VCE through **block credit recognition**.

VET credit towards the VCE, including the VM

From 2023, the following policies will apply to VET credit towards the VCE, including the VM:

- › Students can accrue VCE credit achieved through multiple VET qualifications at Certificate II level or above, up to a maximum of 180 nominal hours of completed units of competency (UoCs). This will give students two VCE units towards the VCE / VCE VM.
- › Students who complete 180 nominal hours of UoCs in a certificate II or above, then move into another certificate III or above in the same industry* will accrue VCE credit at Unit 3–4 level for the next 180 nominal hours of completed UoCs.
- › Students who complete 180 nominal hours of UoCs in a certificate II or above, receiving VCE Units 1 and 2 credit, and then enrol in an approved apprenticeship or traineeship will accumulate VCE credit from the apprenticeship/traineeship in the following order: Units 3, 4, 1, 2, 3, 4.

For example, a student completes 180 nominal hours of training in Certificate II in Kitchen Operations and receives VCE VET Hospitality Unit 1 and 2. The student then decides to move into a Certificate III in Carpentry SBAT. For their next 180 hours of training, they will receive VCE Units 3 and 4. Each additional 90 nominal hours of training would accrue VCE credit in the following order: Units 1, 2, 3, 4.

This policy applies to:

- all SBATs in certificates III or above
- certificate II traineeships that are in the same industry* as VCE VET programs drawn from certificate II qualifications that provide VCE Units 1–4 credit (typically trade pathways or pre apprenticeship qualifications).

VET credit towards the VPC

From 2023, students will gain VET credit into the VPC in the following way:

- › 90 nominal hours worth of completed UoCs from a certificate I qualification or above will provide one credit towards the VPC.
- › Students can accrue credit across multiple VET qualifications, up to a maximum of 180 hours. This will give students two units towards the VPC.

ACTIVE VOLUNTEERING

CERTIFICATE II IN ACTIVE VOLUNTEERING (CHC24015)

Location Lilydale campus

Course Length Part time: 1 year

Class Days and Times

Friday 9:00am-12:30pm L

What Does This Course Involve?

Do you want to gain a qualification that provides a pathway to other qualifications within the community sector and improve your employability skills? This course is designed especially for entry level volunteer workers. Throughout this course you will learn important skills to:

- › work effectively as a volunteer in a variety of capacities and contexts.
- › work respectfully with people from diverse social and cultural groups and situations, including Aboriginal and/or Torres Strait Islander people.
- › participate in safe work practices to ensure their own health and safety, and that of others.
- › communicate in the workplace including gathering, conveying and receiving information and completing routine written correspondence.
- › complete a range of tasks associated with setting up and staging public activities and events.
- › recognise and respond to life-threatening emergencies with appropriate first aid procedures.
- › use personal hygiene practices to prevent contamination of food that might cause food-borne illnesses.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Study Pathways

Upon completion of this course students will gain sufficient skills and knowledge enabling them to commence work effectively in the organisation of their choice, and will gain a qualification that provides a pathway to other vocational qualifications improving their employability skills.

Career Outcomes

This qualification is part of the Community Services Training Package. It reflects the role of entry level volunteer workers.

Contribution to VCE & ATAR

Students undertaking CHC24015 Certificate II in Active Volunteering are eligible for up to two VCE VET units on their VCE (including VCE VM and VPC) statement of results:- two VCE VET units at Units 1 and 2 level.

Structured Workplace Learning

All students are required to complete 20 hours of structured work placement in a volunteer role and 20 hours of Work Placement (1 week).

Subject to the work placement, a working with children check may be required prior to placement.

Tuition and Materials

All fees will be made available to secondary schools. All fees are invoiced to secondary schools.

Uniform Requirements

You will receive a Box Hill Institute polo which is to be worn while completing your structured workplace.

ALLIED HEALTH ASSISTANCE

CERTIFICATE III IN ALLIED HEALTH ASSISTANCE^{^*} (HLT33015)

Location Box Hill campus, Lilydale campus

Course Length Part time: 2 years

Class Days and Times Wednesday 9:00am-12:30pm BH
Wednesday 1:30pm-5:00pm BH, LL

What Does This Course Involve?

This course will teach you the skills and knowledge required to provide assistance to health professionals involved in the care of clients and involves direct client contact under supervision. Within this program you will also develop a range of factual, technical and procedural knowledge relating to infection prevention and control, workplace health and safety, client movement, cultural diversity, workplace organisation and communication.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 11 and 12.

Study Pathways

You may wish to apply for entry into other health programs such as the Certificate IV in Allied Health Assistance (HLT43015) or Diploma of Nursing (HLT54121).

Career Outcomes

After successful completion you may wish to apply for a range of employment opportunities including:

- › patient care assistant
- › health services assistant
- › ward assistant
- › allied health assistant

Contribution to VCE, VCE VM & ATAR

On successful completion of this program, you will be eligible for:

- › recognition of one unit at Units 1 and 2 level, and a minimum of three units at Units 3 and 4 level.
- › Students who receive a Units 3 and 4 sequence may be eligible for an increment towards their ATAR (10% of the fourth study score in the primary four scaled studies).
- › ATAR: Students wishing to receive an ATAR contribution for the Units 3 and 4 sequence of VCE VET Health must undertake scored assessment for the purpose of achieving a study score. This study score can contribute directly to the ATAR, either as one of the student's best four studies (the primary four) or as a fifth or sixth study.
- › The increment is awarded by the Victorian Tertiary Admissions Centre (VTAC).

ANIMAL CARE

CERTIFICATE II IN ANIMAL CARE (ACM20121)

Location City campus#, Box Hill campus, Lilydale campus

Course Length Part time: 2 years

Class Days and Times

Wednesday 9:00am-12:30pm BH, LL

Wednesday 1:30pm-5:00pm BH, C, LL

Friday 9:00am-12:30pm BH – Year 1 only

What Does This Course Involve?

This program provides you with the basic skills and knowledge in order to become an animal carer. You will learn how to care for a variety of animals and provide information on companion animals, products and services.

You will gain the practical skills and basic knowledge you need for entry-level work in the animal care industry. You will learn how to assist with general animal care, provide food and water for animals and follow occupational health and safety procedures in the workplace.

You will undertake work in our animal facility throughout the year giving you the opportunity to work with mice, rats, guinea pigs, rabbits, fish and reptiles. You will also have dogs and cats regularly attend class for practical training.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12. A tetanus vaccination is required for entry into the course. This course involves both practical and written assessments and students will be required to complete work at home between classes. Students must have the physical ability to be able to safely handle small and larger animals, clean animal enclosures and prepare food. A suitable laptop or tablet device is required for all classes as many written assessments will be completed in class.

Study Pathways

You may wish to apply for entry into courses such as:

- › Certificate III in Animal Care (ACM30122)
- › Certificate IV in Veterinary Nursing (ACM40418)
- › Diploma of Animal Technology (ACM50119)

Career Outcomes

This course may provide you with entry level employment in animal rescue centres, pet retail shops, welfare organisations and veterinary clinics, etc.

Contribution to VCE & ATAR

On successful completion you will be eligible for:

- › recognition of up to two units at Units 1 and 2 level and a Units 3 and 4 sequence.
- › Students who receive a Units 3 and 4 sequence for Certificate II in Animal Care (ACM20121) will be eligible for an increment towards their ATAR. (10% of the lowest study score of the primary four).
- › The increment is awarded by the Victorian Tertiary Admissions Centre (VTAC).

APPLIED FASHION DESIGN AND TECHNOLOGY

CERTIFICATE II IN APPLIED FASHION DESIGN AND TECHNOLOGY* (MST20616)

Location Box Hill campus, City campus

Course Length Part time: 2 years

Class Days and Times

What Does This Course Involve?

This course focuses on foundation skills in the fashion design process and is highly suitable for those who have a creative flair and interested in fashion.

The course will help you make informed decisions for a career path in the fashion industry. The subjects will include design, pattern making, garment construction, fashion illustration and textiles. Over the two year course you will produce a design folio and several garments of your choice using industry standard equipment in our creative design hub.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Study Pathways

You may wish to apply for the Certificate IV in Design (CUA40720), Diploma of Social Media Marketing (10904NAT), Bachelor of Design (Fashion Enterprise) (BOD1E), Bachelor of Design (Fashion Design)(BOD1F).

Career Outcomes

On satisfactory completion of this qualification you can pathway into an undergraduate course in fashion enterprise or fashion design which can lead to a variety of career paths in the fashion industry including fashion designer, design assistant, pattern maker, production assistant stylist or fashion buyer.

Contribution to VCE & ATAR

On successful completion of this program, you will be eligible for:

- › recognition of four units at Units 1 and 2 level, and a Units 3 and 4 sequence.
- › Students who receive a Units 3 and 4 sequence for VCE VET Applied Fashion Design and Technology will be eligible for an increment towards their ATAR (10% of the lowest study score of the primary four).

CERTIFICATE II IN AUTOMOTIVE VOCATIONAL PREPARATION (AUR20720)

Location Box Hill campus, Lilydale campus

Course Length Part time: 2 years

Class Days and Times

Wednesday 1:30pm-5:30pm BH, LL

What Does This Course Involve?

The VCE VET Automotive program is the industry endorsed program for secondary school students aiming to enter a career in the automotive industry. This training covers the skills and knowledge required to perform minor maintenance and repair of an automotive vehicle.

Topics covered will include the use of workplace tools and equipment, servicing and inspection of engines, transmissions, cooling, fuel, steering, suspension and braking systems, identifying automotive faults, effective workplace communication and customer relation skills.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Study Pathways

After successful completion, you may wish to continue your studies in an apprenticeship in Certificate III in Light Vehicle Mechanical Technology (AUR30620).

Career Outcomes

This course will give you employment opportunities to start your career as an automotive apprentice.

This qualification may also give you the skills to enter the workforce in the bicycle, marine, motorcycle, heavy vehicle and outdoor power equipment areas.

What Does This Course Involve?

If you're interested in a career in beauty, this VCE VET beauty program is designed to give you the skills and knowledge required as a beautician to provide a range of beauty services including waxing, lash and brow and basic make-up services.

You will develop beauty techniques such as waxing, make-up application, cosmetic tanning and lash extensions.

You will also learn the communication and retail techniques necessary for a career in beauty, all while putting your practical skills to work in a real simulated work environment.

After successful completion you will possess a range of well-developed technical and customer service skills where discretion and judgement is required. This includes client consultation on beauty products and services.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Study Pathways

On successful completion of this course, you may be given credits when applying for the Diploma of Beauty Therapy (SHB50121) that specialises in spa treatment.

Career Outcomes

This course may lead to work in beauty salons and hairdressing salons that provide beauty services.

Contribution to VCE & ATAR

On successful completion of this program, you will be eligible for:

- › recognition of up to four units at Units 1 and 2 level and a Units 3 and 4 sequence.
- › Students who receive a Units 3 and 4 sequence for Certificate III in Beauty Services (SHB30115) from the VCE VET Hair and Beauty program will be eligible for an increment towards their ATAR (10% of the lowest study score of the primary four).
- › The increment is awarded by the Victorian Tertiary Admissions Centre (VTAC).

CERTIFICATE II IN BUILDING AND CONSTRUCTION PRE-APPRENTICESHIP^{^*} (22338VIC)

Course Length Part time: 2 years

What Does This Course Involve?

This VCE VET program specialising in carpentry, will prepare you for a career in the building and construction industry. Topics include industry and workplace safety, the use of hand and power carpentry tools, sub floor construction, installation of window frames and doorframes, workplace documents and plans.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Study Pathways

Successful completion will enable you to progress to an apprenticeship Certificate III Carpentry (CPC30220) or Certificate IV in Building and Construction (CPC40120).

Career Outcomes

This certificate provides an understanding of the building and construction industry, and provides the necessary skills and knowledge to seek employment as an apprentice carpenter, or work within similar roles in the building and construction industry.

Contribution to VCE, VCE VM & ATAR

Students undertaking 22338VIC Certificate II in Building and Construction Pre-Apprenticeship (partial completion) in the VCE VET Building and Construction program are eligible for up to six VCE VET units on their VCE or VCE VM statement of results:

- > four VCE VET Units at Units 1 and 2 level
- > a VCE VET Units 3 and 4 sequence.

VCE VET credit will accrue in the following order: Units 1, 2, 3, 4, 1 and 2. These units of credit may be accumulated over more than one year.

What Does This Course Involve?

This VCE VET program is designed as an introduction to the equine industry. In the first year of the course you will learn the skills and knowledge to work safely with horses including basic horse husbandry and care, understanding equine behaviour, daily work routines and equine anatomy.

In the second year you will learn how to identify and monitor the signs of common illness and injury in horses; understand basic horse physiology and the impact of illness and injury on horses; identify conformation in horses and develop the ability to use appropriate conformation terminology to describe the relationship between conformation, movement and function; and gain understanding of how to implement feeding programs, monitor the quality of feed, feed supplements and individual feeding habits of horses.

Entry Requirements

This course can only be completed as part of your secondary school studies in years 10, 11 and 12.

Students must have the physical ability to be able to safely handle horses and complete tasks such as mucking out stables, moving equipment and tacking up horses.
