Controlling and controlled entities

§74 act no. 90/2012 Coll., Business Corporations Act

- (1) A controlling entity is an entity, which can directly or indirectly exercise decisive influence on a business corporation. A controlled entity is a business corporation controlled by a controlling entity.
- (2) Where the controlling entity is a business corporation, it shall be the parent business corporation. Where the controlled entity is a business corporation, it shall be a subsidiary business corporation.
- (3) A dominant entity pursuant to Section 79 and a majority member shall always be controlling entities, unless stipulated otherwise in Section 75 in relation to the majority member. A dependent entity pursuant to Section 79 shall always be a controlled entity.

 Section 75
- (1) A controlling entity shall be deemed to be the person who can appoint or recall the majority of the persons that are members of the statutory body of the business corporation or persons in a similar position, and members of the supervisory body of the business corporation of which it is a member, or who is able to enforce such appointment or recall.
- (2) A person shall be deemed to be a controlled entity, if he or she controls a share in the voting rights representing at least 40% of all votes in the business corporation, unless other person or persons acting in concert control the same or a higher share.
- (3) Persons acting in concert, who jointly control a share in the voting rights representing at least 40% of all votes in the business corporation, shall be deemed to be controlling entities, unless other person or persons acting in concert control the same or a higher share.
- (4) A controlling entity or controlling entities shall be deemed also include a person who, individually or jointly with persons acting in concert, acquires a share in the voting rights representing at least 30% of all votes in the business corporation, where such share represented more than half of the voting rights of the participants attending the past 3 consecutive meetings of the supreme body of such business corporation
- ii a politically exposed person shall mean:
- a) a natural person in a prominent public position and with nation-wide responsibilities, such as a head of state, a head of government, a minister and deputy or assistant minister, a member of the parliament, a member of a supreme court, a constitutional court or another high-level judicial body, decisions of which are not subject to further appeal, except in exceptional circumstances, a member of a court of auditors or
- a central bank board, a high-ranking military officer, a member of an administrative, supervisory, or management board of a state-owned business, an ambassador or chargé d'affaires, or a natural person, having similar responsibilities on a Community or international level; all the above for the entire period of the position and for one year after the termination of such position, and provided the person:
- 1. has residence outside the territory of the Czech Republic, or
- 2. holds such important public position outside the Czech Republic,
- b) a natural person, who:
- 1. is the spouse, partner equivalent to the spouse or a parent of the person under letter a),
- 2. is a son or a daughter of the person under letter a) or a spouse or a partner of such son or daughter (a son or daughter in law),
- 3. is a business partner or a beneficial owner of the same legal person, a trust, or any other business entity under a foreign law, as the person under letter a) or is known to the obliged entity as a person in a close business relationship with a person under letter a), or 16) Section 20(f) et seq., Civil Code. Act No. 83/1990 Coll., on Public associations, as amended.
- 4. is a business partner or a beneficial owner of the same legal person, a trust, or any other business entity under a foreign law known to have been established in benefit of a person under letter a).
- iii country of origin for
- 1. a natural person means each country of which such person is a national, and concurrently all other countries in which such person has a registered residence for over 1 year, or a permanent residence, if known to the institution,
- 2. a legal person subject to obligations pursuant to Article 24a of the Act or equivalent obligations pursuant to the legislation of another country, the country in which it has its registered office,
- 3. a legal person not subject to obligations pursuant to Article 24a of the Act or equivalent obligations pursuant to the legislation of another country, the country in which it has its registered office, and concurrently all countries in which it has a branch
