

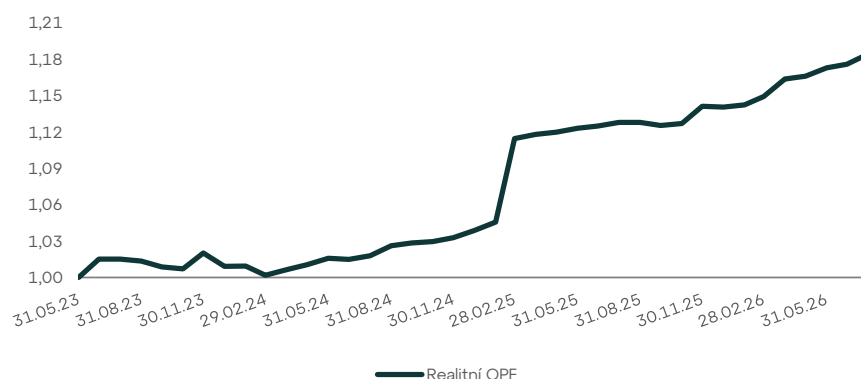

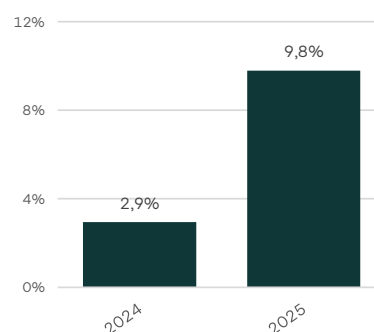

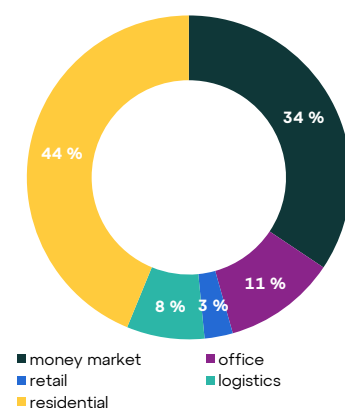

Investment Strategy

The investment strategy of the Fund focuses on ownership of real estate assets, operation, letting and lease management of office buildings, shopping centres and potentially other commercial assets located in capital cities and, in later stages, larger regional cities of the Czech Republic, Slovakia and Poland. The Fund may also invest in other related financial assets. The Fund is denominated in Czech korunas. Currency risk is actively managed to maximize performance in Czech korunas.

The Fund's expected long-term return (after fees) is targeted at the level of **7% - 9% p.a.**
