### **Admissions Policy**

As a voluntary aided Church of England school, Hampden Gurney provides an education based on Christian principles and has close links with its parish church, The Annunciation, Bryanston St, London W1H 7AH. It is expected that all children take part in the life of the school, including the daily act of Christian worship and religious education lessons. This does not remove the right that parents could request that their child, or children, to be withdrawn from these activities.

Hampden Gurney C.E. Primary School, Nutford Place, London W1H 5HA, admits a maximum of 30 children into its Reception Year. For **2021-2022**, these children will be **born between 1st September**, **2016 and 31st August**, **2017**.

Parents who wish their child to be considered for a place in the school should complete a Common Application Form from their home LA naming the school. When applying for a place on religious grounds, please complete the religious attendance SIF (which follows from this Policy) and so that the Governors' Admissions Committee may consider the application fully.

#### **Education, Health and Care Plans**

Children with a Statement of Special Educational Need or with an Education, Health and Care (EHC) plan naming this School will always be offered places if they are available.

**ADMISSION CRITERIA** Where there are more applicants than places, Governors of the school will allocate places in accordance with the following order of priority:

**1.** Looked-after children and children who were previously looked after, but ceased to be so because, immediately after being looked after, they became subject to an adoption, child arrangements or special guardianship order.

\*Note: By a "looked-after child" we mean one in the care of a UK local authority or being provided with accommodation by a UK local authority in the exercise of its social services function. An adoption order is one made under the Adoption Act 1976 (Section 12) or the Adoption and Children Act 2002 (Section 46). A 'child arrangements order' is one settling the arrangements to be made as to the person with whom the child is to live (Children Act 1989, Section 8, as amended by the Children and Families Act 2014, Section 14). A 'special guardianship order' is one appointing one or more individuals to be a child's special guardian/s (Children Act 1989, Section 14A). Applications under this criterion should be accompanied by evidence to show that the child is looked after or was previously.

2. Baptised children of Church of England families who attend the Parish Church of The Annunciation.

**3.** Baptised children of Church of England families who attend another Church of England Church.

**4.** Baptised children of other Christian communions. These Christian communions are members of Churches Together in Britain and Ireland. (Churches Together in Britain and Ireland is the successor body to the British Council of Churches, and co-ordinates the work of the four nations.) Details of these churches may be found by following the link from the school's website.

5. Baptised children of families who currently attend a Church of England church but cannot show evidence of 3 years' attendance, 26 times per year from 16<sup>th</sup> January 2018.

6. All other children.

#### For children to be considered based on priorities 2, 3 and 4, it must be shown that:

a. such child has attended their place of worship with their parent/guardian **at least 26 weeks per year**, for a **full three** years, prior to the closing date on your application form.

b. at least one parent/guardian has been a communicant member of such place of worship and/or registered on such place of worship's electoral roll for this 3-year period.

The Religious Attendance Details section of the SIF must be completed by the Vicar/Priest/Minister/Religious Leader to confirm this. A copy of your child's baptism/dedication/other certificate must also be provided with your application.

If the child has attended or is attending a second place of worship with their parent/guardian during the 3 year period prior to date of your application, then you are invited to provide evidence of other church attendance. You can do so by passing the Supplementary Information Form (SIF) to the minister of your second place of worship to complete the '2<sup>nd</sup> Religious Attandance Details' section of the SIF. For a child to be considered under Criterion 2, it must be shown that both a. and b. above are wholly satisfied with the Annunciation as the place of worship.

Attendance at a Church of England church, including the Annunciation, <u>for less than 3 years</u> will be aggregated with attendance at their previous church. If the previous church is a member of the Anglican Communion, the child will be considered under criterion 3. If the previous church is a member of Churches together in Britain and Ireland, the child will be considered under criterion 4.

#### **TIE-BREAKER**

In the event of over-subscription in any of the above criteria, priority will be given to:

**FIRST:** Children with siblings already on the roll of the school who will still be in the school at the time the applicant is admitted. This includes half-brothers or half-sisters, adopted brothers or sisters, step-brothers or step-sisters or the children of the partner of the parent or carer, provided they live at the same address as the applicant. Please note sibling priority only applies to children with sibling(s) at the school in Reception to Year 6 at the time of admission. Nursery is not included.

**SECOND:** Children living closest to the school. Where the order of priority is otherwise equal, preference will be given to a child who lives the shortest distance from the school. Home address is defined as the address at which the child resides for 50% or more of the school week. Distances are measured by a straight line from the address seed point (determined by Ordnance Survey data) of the child's home address to the main school gate for pupils, as measured by the Local Authority's computerised measuring system. Where it is necessary to differentiate between applicants living in flats using the same street entrance, priority will be given to the applicant(s) living closest to the ground floor and then by ascending flat number order. Where it is necessary to further differentiate between applicants living the same distance from the school, priority will be decided by random allocation.

Any attempt to mislead the School or Westminster City Council may result in the withdrawal of the offer of a place.)
