

REGRETFULLY ANNOUNCE SAD NEWS EXECUTION SIX BAHA'I FRIENDS IN TIHRAN:

DR RUHULLAH TA'LIM FROM KIRMANSHAH, DR FIRUZ ATHARI, MR INAYATU'LLAH HAQIQI, MR JAMSHID PUR-USTADKAR, MR JAMAL KASHANI, MR GHULAM-HUSAYN FARHAND.

LAST FIVE PREVIOUSLY NOTIFIED TO YOU AS AMONG THOSE CONDEMNED TO DEATH. FATE OF REMAINING 19 IN BALANCE. ALL EXECUTIONS TOOK PLACE ON THE SAME DAY 9 DECEMBER. DETAILS ARE UNKNOWN AS NEITHER RELATIVES FRIENDS WERE INFORMED. FACT OF EXECUTIONS DISCOVERED EIGHT DAYS LATER.

ADVISE PUBLICISE FACTS AS MUCH AS POSSIBLE AND INFORM AUTHORITIES. SITUATION GRAVE.

FURTHER OUR TELEX 17 DECEMBER WE SORROWFULLY ANNOUNCE NEWS EXECUTION BY HANGING OF DR FARHAD ASDAQI ON 19 NOVEMBER AFTER FOUR MONTHS IMPRISONMENT AND TORTURE. MR DIYA'U'LLAH MANI'I-USKU'I AND MR 'ALIRIDA NIYAKAN - THESE TWO MEN DIED IN TABRIZ PRISON 13 AND 11 NOVEMBER RESPECTIVELY AFTER TWO AND A HALF YEARS IMPRISONMENT. CAUSE DEATH NOT ESTABLISHED.

DISTRESSED INFORM YOU THAT RECENTLY IRANIAN GOVERNMENT ANNOUNCED ANOTHER OPPRESSIVE MEASURE AGAINST BAHA'I FRIENDS. IN ORDER TO BE RELEASED, PRISONERS MUST SIGN FOLLOWING UNDERTAKING:

"I THE UNDERSIGNED (DETAILS OF PERSONAL STATUS INCLUDING RELIGION) UNDERTAKE NOT TO HAVE IN MY POSSESSION ANY BOK, PAMPHLET, DOCUMENT, SYMBOL, OR PICTURE OF THIS MISGUIDED, ZIONIST, ESPIONAGE GROUP OF BAHA'IS. IF ANY OF THE ABOVE-MENTIONED ARTICLES BELONGING TO THIS HATED UNDERGROUND MOVEMENT IS FOUND ON MY PERSON, OR IN MY HOME, THIS WILL BE TANTAMOUNT TO MY BEING OF THOSE 'WHO WAR AGAINST GOD' AND THE ATTORNEY-GENERAL WOULD BE FREE TO DECIDE AGAINST ME IN THE MANNER HE DEEMED FIT".

THE TERMINOLOGY 'WHO WAR AGAINST GOD' IS A TERM USED BY PRESENT REGIME TO SIGNIFY A CRIME DESERVING SENTENCE OF DEATH. BAHA'I PRISONERS HAVE REFUSED SIGN SUCH AN INFAMOUS DOCUMENT FALSELY IMPUGNING THEIR FAITH. MOREOVER SIGNING SUCH A DOCUMENT WOULD LEAVE BAHA'IS OPEN TO HAVING SUCH ITEMS PLANTED ON THEIR PERSON OR IN THEIR HOMES.

WAVE RECENT ARRESTS OF BAHA'IS SUGGESTS THAT AUTHORITIES PLAN EXERT PRESSURE ALL BAHA'IS TO SIGN SUCH AN IMPOSSIBLE UNDERTAKING. OBVIOUSLY FAITHFUL FRIENDS WILL REFUSE TO SUCCUMB SUCH CONTEMPTIBLE PLAN.

WE REQUEST YOU PUBLICISE AND INFORM GOVERNMENTS OF DETERIORATING SITUATION BAHA'I COMMUNITY IRAN.

At a recent National Spiritual Assembly meeting, certain decisions have been taken, which we feel will be of interest to the Community at large, and we therefore list them below for your information.

PUBLICATIONS

If the Baha'i Publishing Trust does not stock items which are published by other Trusts or agencies, the friends are free to purchase them from elsewhere, including outside the country. Moreover, the Baha'i Publishing Trust has a responsibility to publicise those books it does not stock, and inform the community where they can be obtained.

UNIVERSAL HOUSE OF JUSTICE: PLEA FOR PHOTOGRAPHS

It has been brought to our attention that while the current circumstances in Iran make it extremely difficult, if not impossible, for photographs of the persecutions to be taken by the friends, it is likely that those who fled the country may have taken out with them photographs or other graphic materials depicting the persecutions. We have been requested to inform the Baha'i refugees who have settled in our country, or who are passing through, of the need for such materials to be made available to the World Centre as soon as possible. It would be necessary for a description to accompany each photograph. including name, date, place, occasion, etc. These photographs can be sent on behalf of the donors to the National Office, which will then forward them on to the World Centre.

The Universal House of Justice has appealed for written accounts of our Ten Year Crusade pioneers to be sent to the World Centre. The House has requested biographical information, photographs, and a sketch of their services during that period of time. HUMAN RIGHTS pt 2

THE BAHA'I DECLARATION OF HUMAN RIGHTS

It was submitted by the National Spiritual Assembly of the Baha'is of the United States and Canada. in February 1947, on behalf af all eight National Assemblies then in existence.

It is written in rather grandiose language which in parts would be improved by simplification, but it needs to be studied as it immediately points to the vital differences between the Baha'i approach and that of the United Nations Declaration.

- 1. Established by the title "Obligations" before "Rights". Obligations of man to God, to society and to himself.
- 2. Human Rights are God-givenrights as He has endowed all
 mankind with qualities, virtues
 and powers, and that the purpose
 of human existence is to fulfil
 the posibilities of God's
 endowment.
- 3. Humanity is evolving and maturing and as new qualities unfold so the social structure must change. The national state has reached the limits of independent development and a new international order need to be born based on the wholeness of human relationships and the recognition of the oneness of mankind.
- 4. Prophetically it states that by delaying our response to the call to our age to unite, "we give opportunity and encouragement to subversive forces whose weapon is confusion and whose aim is chaos."
- 5. It states that its purpose is not to "catalogue every desirable human right" but to suggest an approach to the subject.
- 6. It lists seven essential human rights, three of which are left untouched in the UN declaration.

- I. The Individual man is a spiritual being as well as being a member of society.
- II. The Family while the human person is the spiritual entity of mankind, the family is the divinely created social entity. The equality of men and women is touched upon.
- III. Race exclusive race rights to be exchanged for the rights and privileges of a multi-racial society.
- IV. Work The bald "right to work" of the UN declaration contrasts most strongly with the lengthy section on "work" in the Baha'i declaration. Work in a trade, craft, art or profession is the core of a person's life, not merely the source of livelihood; it ranks as worship if done in the spirit of service; work establishes the right to a living and also gives the right to a share in the profits. When a world view predominates and world institutions are formed, the nature of international competition will change (again most prophetic). World peace is a first step to a sound economy.
- V. Education the purpose is defined as also is the role of the prophets as universal educators. The whole man should be the object of education and education is continuous throughout life. It states: "Systems producing rigidly moulded attitudes....can no longer claim to be educational."
- VI. Worship Article 18 of the UN declaration deals with the right to freedom of religion, to change one's religion and to manifest it in "teaching, practice, worship and observance." The Baha'i concept goes far beyond that nad brings in loyalty to mankind and the devotion to the cause of world unity. It mentions progressive revelation and concludes that world order is only the administrative aspect of

a right to a social order, he also has the right to a world faith.

Order - is also VII. World treated as a fundamental right and it is an obligation of humanity to form such an order. Federal world government and it states that "until world citizenship is guaranteed.... human rights.... developed in the past are undermined by the disruption of modern society". However, governments have a right to loyalty and obedience except when they "interfere in the individual's they faith in God and His prophets. Its final paragraph uses the words and ideas given by Shoghi Effendi in his "World Order" letters.

BAHA'IS AND HUMAN RIGHTS

When we examine closely the developments which have taken place in the world in the 36 years since the UN declaration, we must marvel at the enormous advances which have been made, particularly in comparisonwith the slow, slow progress of the past 4,000 years. since 1948 there have been no fewer than 22 conventions or Covenants adopted, 13 declarations made, and 11 major international conferences held, all on human rights issues. 121 states have ratified the Convention on the Elimination of all forms of Racial Discrimination; 96 for the Slavery Supplementary Convention, 92 for the Status of Refugees and 80 for the Covenant of Economic, Social and Cultural Rights.

Even so, the activists in these fields are impatient with the tardiness of some countries, frequently there is an outburst in the media when some area or people suffer from an obvious denial of basic human rights and freedoms.

Few people however, pause to ask why it is that so much progress has been made in such a relatively short time in human history. The changes have been revolutionary rather than evolutionary, and there must be a reason.

brotherhood, and just as a man has As Baha'is, we believe it to be the release of the spirit flowing through Baha'u'llah as God's Manifestation for today, and the immense speed upin all forms of development as well as in the universal recognition of human rights, is due to mankind's coming of age.

> With this knowledge and with our dedication to the call Baha'u'llah, we continually seek to be in the vanguard of progress. responding to the guidance of Shoghi effendi, continued by the Universal House of Justice and supported by the work of the Baha'i International Community. the Basha'i world has given its full support to the United Nations, particularly in the field of human rights.

> We have, in spite of the differences of emphasis we give to the subject, observed Human Rights Day, been very involved in Human Rights Year (1968) and are now in the United kingdom seeking, during the International Youth Year, to promulgate the Universal declaration, stress its provisions, and make all young people aware of its existence and importance as a common standard for all mankind.

> While falling short of the higher standard given to us by Baha'u'llah, while failing to emphasise the greater spiritual man, while being needs of restricted by its purely national application among the UN member states and while it cannot be fully implemented even in its present form until the Lesser Peace is established, it is still a giant step forward and should be seen as such by all mankind.

> In our efforts to get it to the attention of all schools throughout the United Kingdom, we shall need to work hard tirelessly, to seek the cooperation of others sympathetic to the plan and to inspire other organisations to support the project. This in itself will be a worthwhile and very challenging

campaign for all our youth but than this, it will help us realise the wider issues see the greater involved. to vision of our Faith, become to aware of the fundamental verities of the Cause. introduced to new facets in our Scripture and to develop a growing awareness of just how much Baha'u'llah, in the words of the Universal of house "repeatedly and variously declared 'progress of the world' the 'development of nations' as being among the ordinances of for this day".

It will also, God willing. bring into contact with many more who. like ourselves. realise that there is much to present-day desires in the approach to human rights and who will, when hearing of Baha'ullah's "Call to the Nations" respond in a positive way.

In the last Journal we enjoyed a humorous article on "American Football" - at least, we hope you enjoyed it as much as we did. So, continuing in a sporting style, herewith the N.T.C's contribution...

"THE RACING PAGE"

(Horse Racing Commentary) ...

Racing at Rutland Gate:

THE UNITED KINGDOM VICTORY STAKES

All races run over 23 furlongs (months), with only 15 furlongs to go and the halfway point at 12 furlongs (Ridvan 1985).

2 o'clock The South of England Challenge Cup

Line up: 6 horses in the field.

- Hants and Wight This horse is carrying rather a lot of No. 21A weight with 7 goals and only 5 LSAs, plus a small handicap with a modest water jump! Nevertheless going courageously in spite of the need for some encouragement from the stands.
- No. 21C Channel Islands Rather an 'outsider' with considerable handicap needing steady support from outside. Exciting news of a pioneer couple trying hard for Jersey (the goal) will put this horse on the road to victory. One more couple, and a steady input of teaching teams during the coming summer months should make this horse a winner.
- West of England Carrying by far the most weight with 9 goals including 4 unopened districts, handicapped with one LSA currently under numbers and a large area (4 counties) to cover. Since Area Teaching Conference, No. 23 has been picking up valiantly. Maintaining the fine spirit, this horse could well surprise us all, especially if some more help from outside could be forthcoming.
- Devon Maintaining a steady gallop and a fine spirit, No. 24A placed about the middle of the field, but with a pioneer due to move into the unopened district any minute, the 4 LSAs striving for the 4 goals present a balanced and united front for the race to victory.
- No. 24B Cornwall Coming up fast on the far side to challenge Sussex for the 'all goals achieved'! May well overtake at the halfway post when a lapsed assembly (Restormel) joins the running. It will be neck and neck to see which of these two lead the remaining 12 furlongs to the winning post.

2.30 The Northern Ireland CommUNITY Trophy

No.1 This is a difficult race with special handicaps, but with a truly wonderful manpower in the saddle. Situation at the 15 furlong post (Jan. 1985) shows some formidable hurdles still to be jumped as 9 LSAs chase 10 goals plus 3 LSAs under numbers! It means going flat out without flagging to pass that winning post, and help from the stands would surely be greatly appreciated, plus some powerful injections of prayers regularly and often.

3 o'clock <u>Eastern Counties Handicap</u>

Line-up of 4 horses:

- No. 16A <u>Cambridgeshire</u> Leading the field with all goals achieved and only needing to maintain its place to the winning post. Nevertheless, to make this race a total victory, LSAs in 16A should be looking out to lend some dynamic support to the other horses racing.
- No. 16B

 East Anglia Over on the far side of the course, carries quite a handicap over a wide area. Nevertheless 5 LSAs with only 5 goals to achieve, and outside support from lucky Cambridgeshire and the news of pioneers moving into Suffolk Coastal and Mid Suffolk should make this race a walkover for this horse.
- No. 14

 East Midlands This horse has a most daunting handicap 23 districts in 3 large counties, and only 4 LSAs in the saddle! Goals include 3 assemblies and 6 unopened districts, plus a very wide area to cover. Definitely this horse is a priority for help from outside, including special doses of prayers at regular intervals and frequent teaching visits. Nevertheless, a fine spirit prevails and there has been some noteworthy motion during the past few months, with more planned in the near future.
- No. 15

 South East Midlands This horse is also carrying some considerable weight 6 goals to achieve including 1 assembly and 3 unopened districts. However 5 LSAs spread throughout the area achieve a balance which hopefully will maintain an increasing pace of activity to the winning post.

3.30 The Welsh and West Midlands Hurdles

This is a truly strenuous race for the line up of 4 horses, over very rough ground indeed. The going is hard and gruelling right up to the very last furlong in spite of the advantage of a fine set of Motorways and outstanding coastal and mountain scenery to entice pioneers.

No. 10

Cheshire & North Wales

Currently leading the field,
although still with 7 goals to achieve of which 3 are
unopened districts. Exciting news, though: Congleton
may be opened at last, soon! Also with 12 districts to
maintain over a mountainous terrain. A strict diet of
prayer has done a lot to get this horse into a fine

position to win, together with a lot of of nutritious 'spiritualisation' plus 'intensified personal teaching' as the number of recent declarations testifies.

- West Midlands Running next to No. 10 this horse is No. 12 rather heavily handicapped, with only 2 LSAs, and with 8 goals to achieve, including 4 unopened districts and 3 assemblies distributed over a wide area of both solid industrial and wild rural terrain. There has been some good steady movement in the right direction in the last 2 furlongs which strengthened one community and formed a new group (Sandwel). This fine spirit may well carry it over the remaining hurdles, nevertheless this horse needs every support from the stands to win the day.
- S.W. Midlands Very similar to No. 12, covering an even No. 13 larger area of 3 counties +, this horse suffered a setback when a district was left unopened, adding to the already impressive handicap of 7 goals to achieve. good news is that a pioneer couple are about to move into a lapsed county assembly goal. Hopefully the Area Convention will help this horse to put a spurt on and get the momentum increased over the remaining 15 furlongs.
- Central & South Wales Over on the far side of the No. 11 field, this horse has not been having an easy time until now, and has by far the heaviest handicap - 12 goals to achieve! However, the manpower is there, and with a bit more movement, miracles can still be expected. As it is, at least one lapsed Assembly (Rhondda) will join the running at the halfway post, with another (Monmouth) in the offing as a bonus. News of a declaration in an unopened district will get this mount over yet another hurdle. Urgent help is needed in the Aberystwyth region to save an assembly.
- 4 o'clock The Scottish Thistle Challenge Cup

Like the 3.30, this is a handicap race over mountainous terrain with some formidable water jumps to be taken into consideration. There are 4 horses in the line-up:

- Highlands & Islands With 3 LSAs staunchly striving for No. 2 2 more assemblies and 2 unopened districts, this horse has suffered one or two setbacks in the past few months, but the fine spirit prevailing should maintain and even build up a good momentum to the finishing post.
- N.E. Scotland & Shetlands With only one goal toachieve No. 3 at this stage of the race, and fine recent activity in the goal area, and 5 LSAs standing by for input, this horse should get to the winning post without difficulty.
- East Scotland With 3 LSAs plus another presently under No. 4 numbers, the 3 group goals still to be won have been given movement in the right direction with 3 sets of pioneers recently moving in. With such staunch manpower in the saddle, the race should be a walk-over.
- No. 5 S.W. Scotland This horse responded magnificently in the opening furlongs of the race and quickly established a

new assembly (Kilmarnock). Nevertheless, this horse has more weight to carry than any other in this race: 6 goals including 3 unopened districts, and an LSA currently under numbers. However, with 9 LSAs going flat out for the remaining furlongs, and maintaining the good spirit in spite of special handicaps, the outlook is positive for complete victory in the last lap.

4.30 The Northern Counties Trophy

All mounts in this race have over 20 districts to cope with, and individual handicaps which make the running anybody's win. Only 3 horses in the line-up:

- No. 6

 North West England With a top end (Cumbria) spread over a wide area, and the south end (Lancashire) carrying all the weight of goals, it is obvious that the majority of activity will need the best possible support from the 4 LSAs nearest to the work area, plus some travel teaching teams from outside. However, with some well co-ordinated movement in the right direction, the hurdles should not be insurmountable.
 - No. 7

 North East England In spite of the shortage of manpower in the saddle (3 LSAs only), this horse is facing up to the challenge in fine spirit and what a challenge!

 One county goal (Middlesbrough) needing special support,

 4 groups and no less than 6 unopened districts! Definitely needing every support from outside during the remaining furlongs of the race.
 - No. 8 Yorkshire & Humberside Deceptively the race for this mount is widespread over 4 counties, with the manpower in the south-west and the goals in the east. Handicaps include 3 of the 11 LSAs under number and 9 goals to achieve! NOT a walkover, but the very fine 'DATADAY' newsletter is spurring on the activity, and a fine spirt of confidence in the victorious outcome of the race prevails.
 - 5 o'clock At last! The race you have all been waiting for. Your bets (prayers) please, for

The London & Manchester Tandem Handicap

By far the largest line up, no less than 10 horses running, all of them in double harness. The stakes are high, and, at this time it could be anybody's race:

- Nos. 9A & B: Manchester & Merseyside On the far north of the field, these two mounts are getting it together nicely and may well lead the field due to the compact area. Manpower just a little bit sleepy so far and some consolidation of the gains will be needed with, perhaps, a bit more "Universal Participation" and this horse should reach the winning post in fine style.
- Nos. 17A & B: Essex & London East Plenty of movement here in Essex but perhaps a little more movement needed in B which is sadly limping with 3 LSAs under numbers. Needs to make a bit more use of the excellent travel facilities to get this couple going well together to the finishing post.

With 4 goals and a handicap of 5 LSAs under numbers, in spite of plenty of manpower, this pair have no cause to be complacent.

- Nos. 18A & B: Central England & London North This pair are going very well indeed, co-ordinating beautifully and are a pleasure to watch. Nevertheless, there are handicaps (2 LSAs under numbers and still a lot of weight to carry with 4 new assemblies to form, plus 2 groups and a lapsed assembly to re-establish. Again, there is no room to rest and take it easy.
- Nos. 19A & B: West London, Oxon & Berks This pair got away to an excellent start ahead of the field, with one new LSA (Hillingdon) doubling its numbers at the seventh furlong! With all the goals in A, this horse is the most energetic of the two, and some sustained support from West London is now necessary to win the day.
- No. 20 Kent & London S.E.

No, this horse does not look like a pair but this and the next, 21B, are in the same situation as the others, and the deceptive situation indicates that more coordination is needed between the town and country interaction. Alas, Kent not only has nine goals to strive for but a handicap of one LSA under numbers (Sevenoaks). But the good news is that one unopened district (Gillingham) may soon be opened again. A revitalizing Area Convention, plus regular doses of the excellent Area Newsletter, should pick up the momentum and get this race well in hand.

No. 21B

Surry & London S.W. With only 4 goals to achieve and one lapsed assembly (Sutton) due to join the running agin at the halfway post, this horse should have no difficulty in passing the winning post with flying colours. Handicaps, however, include an LSA currently under numbers (Waverley), and a major handicap in that this is the 'twin' of No. 21A which ran in the two o'clock, and so some precious energy will need to be consecrated to ensuring that both reach the end of the race in style. More assistance from the large communities in London S.W. will be needed to help with the race.

The N.T.C. plans to give up-date reports on the progress of this race at intervals of 2-3 months, and the next 2 'furlongs' should make it very exciting as we come up to the halfway post at Ridvan 1985. We all know that we are encouraged to vie with each other when teaching the Faith, so Gee-Up and Tally Ho"... Each One Teach One!!

PROJECT THE FAITH INTO THE PUBLIC EYE

Without doubt the Project for the International Youth Year is the single most important project that the United Kingdom Baha'i community has undertaken in recent years, perhaps ever.

Yet this project, to aquaint all the secondary school youth in the country with the United Nations Declaration of Human Rights, is not primarily a Baha'i project. So why is it so important?

One of the benefits that the community will gain from this exercise is the publicity that the project can generate. Already there have been several newspaper reports. This month's cover is similar to an advertisement that is appearing in RE News and Views, a magazine for Religious Education teachers throughout the country, which is sent to every school in England and Wales. In the International Youth Year magazine, a report has already appeared outlining the Baha'i project, and conveying the enthusiasm the committee felt towards it. As time progresses, more and more organisations, both youth and otherwise, will meet the Baha'is face to face for the first time and see the valuable contribution that the Baha'is can make.

For example, in London, where the Greater London Council has just completed an anti-racist year one single Baha'i girl attended a youth meeting. Following a morning of relatively constructive discussion a film was shown. As sometimes happens, the film was terrible, it was decidedly racistbut anti-white and anti-police, to such an extent that the youth

there began to boo the police every time they appeared on the screen. Whatever constructive work had been achieved during the morning session was destroyed by this film. The conference would have been a waste of time, and indeed would have worked against the whole idea of the conference. However, an opportunity was given for questions and comments from the floor. Among the first to speak was this one Baha'i. She pointed out that the film was racist - that it was anti-white, which made most stop and think for she is very dark skinned. She went on to point out that the film was also biased against the police, which could only worsen the situation. Following these points the dicussion became more constructive and the atmosphere became more relaxed and tensions eased.

This is an excellent example of how just one Baha'i can affect many. The saddest thing about this conference was the fact that although many of the Baha'i youth in the London area had been told of the conference, only one bothered to show up. If we miss many more opportunities such as this who can we blame for the breakdown in society but our own apathy and indifference?

This project is certainly the biggest undertaking that the UK Baha'i community has undertaken. But we should have no doubts at all that we can achieve our goal. When the Baha'is throughout this country get going, know what they must do and wholeheartedly arise to do it, the results can be most impressive. For example, each year MPs get lobbied by many groups who wish to make their opinions known. Many of these groups have much larger resources to draw upon. Look how many supporters CND have, compared to the few thousand Baha'is that we can call upon. Yet when we lobbied the MPs about the situation in Iran, MPs were heard to remark that they had never seen such effective lobbying! So it is not merely "by the force of

Perhaps the most radical aspect of the project is the fact that we are not promoting the Baha'i Faith. The pamphlet which comes with (not in) the schools information pack is there to be offered as information about the Faith should the school want it. The rest of the material is what is the most important. Communities have been asked to reproduce the Declaration of Human Rights not the Baha'i pamphlet. Inside the declaration schools are told where to get more information on the Baha'i project, not the Faith itself.

Why is this? Surely we should be more concerned with spreading the message of the Faith and telling people what Baha'u'llah has written, not some committee of voices, crying out at our National United Nations lawyers or Convention, our Teaching Conferenwhatever. We cannot hope to get the same response from schools if meetings that it is the youth who we are merely telling them about some strange eastern religion as is the youth who must use their we will, indeed already have boundless energy and zeal for the received from the schools telling Faith? By undertaking this project the Faith is promoting itself, not as a religious sect seeking converts but as a humanitarian body actively seeking the betterment of society. The following are extracts from the Hansard covering the debate:

Mr. Roger Freeman (Kettering):

While the persecution increases, the Government should increase their pressure on Iran. Full advantage should be taken of the recent improvement in relations between the two countries—an improvement which I wholeheartedly welcome. Regrettably, the openings for

such action may be limited. The House will realise the many limitations upon direct pressure and persuasion, but the Government should continue to pursue this matter within the forum of international organisations.

The opportunity exists for the Government to exploit the thaw in relations for the good of the Baha'i. Those who are suffering in Iran, and those in my constituency, other constituencies and throughout the world, who live in constant fear for the lives of their families and friends in Iran, beg the Government to do all that they can and to use all their goodwill and muscle, directly and indirectly through international organisations, for the sake of the Baha'i community in Iran.

The Minister of State, Foreign and Commonwealth Office (Mr. Richard Luce): My hon. Friend the Member for Kettering (Mr. Freeman) has done the House a service by raising this important matter, and I congratulate him warmly on the great deal of thought that he has put into the issue and on the knowledge that he has displayed of the plight of the Baha'i people in Iran. I assure him that I listened carefully to his views.

This matter causes the Government much concern. Indeed, they have taken several positive steps to try to help the Baha'i community in Iran, and I shall describe some of those steps in a moment. My hon. Friend echoed the disquiet that has been expressed by many hon. Members for many months, if not years. I have received many letters from hon. Members expressing anxiety on behalf of their. constituents about the position of the Baha'i community in Iran. I will go further and say that I maintain close contact with representatives of the Baha'i community in the United Kingdom. Only yesterday I met the Secretary of the National Spiritual Assembly of the Baha'is of the United Kingdom, Mrs. Hardy, who also visited me in 1983 to express her worries about the Baha'i community in Iran. The assembly in this country keep me and the Foreign and Commonwealth Office officials carefully briefed about developments there and their own anxieties -above all, about the imposition of the death penalty on many Baha'is. I can assure my hon. Friend that we shall continue to keep in very close touch with the leaders of the community in this country.

As for Iran, one of several countries in which human rights abuses cause us great concern, the Baha'i community is subject to real and particular suffering. Our overriding concern as a Government, and that of my hon. Friend, is the safety and well-being of those to whom we are trying to give help. We must never at any stage do anything that we believe might jeopardise their prospects. Western representations on behalf of the Baha'i community have, on occasions, served only to strengthen Iranian feelings against the Baha'is. Britain is not the country best placed to make bilateral representations on behalf of the Baha'is. Our historical involvement in Iran is an important factor that militates against our success in this matter at the moment. We must take care not to take action which is counter-productive. I am sure that my hon. Friend would agree with that.

Equally, we shall not be afraid to voice concern and disquiet where that is necessary, appropriate and helpful. Against that background, in general, our best approach on the issue is to act in concert with our partners in the Ten

and to couple that with action in international forums. A good deal has been done in both those respects.

I shall consider carefully the other points made by my hon. Friend. The plight of the Baha'is is a matter of legitimate international concern, and Her Majesty's Government will continue to take whatever action we judge to be the most helpful in partnership with the international community. I assure my hon. Friend that the anxieties of the Baha'i community will remain a matter of deep concern to my right hon. and learned Friend the Foreign Secretary and myself in the coming months.


