In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.


We project that carbon emissions will decrease over the next five years to 169.8 tCO2e by 2029. This is a reduction of 23.8 %.

Although are carbon emissions have not reduced compared to our baseline year, this initial period has been valuable in deepening our understanding of the company's overall emissions profile. Our primary focus in the current year is to reduce emissions, particularly Scope 3, where we have identified the greatest opportunities for meaningful impact.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2023/24 baseline and the measures will be in effect when performing the contract.

- Hybrid working pattern
- New offices have high BREEAM rating
- Solar panels on warehouse, now producing excess solar energy being fed back into the main grid
- Implemented segregating food waste and separate disposal
- Created a 'Green Team' to help communicate strategy and drive change
- Purchased hybrid cars for engineers.

In the future we hope to implement further measures such as:

- Reduce commuting emissions by 7% by 2026 by sign-posting car share schemes
- Introduce public transport first policy
- Ensure, where possible, all electric items are turned off at wall when not in use & implement energy saving IT settings for all employees
- · Investigate training on fuel efficient driving
- Engage with distribution partners to utilise eco-friendly distribution options
