Casilda has worked extensively in matters relating Article 101 investigations. In Spain, her experience includes information exchanges in the tobacco industry, and horizontal cooperation agreements in the bus transport and textbook publishing industries. Casilda also advised Brussels Airlines and TAP during the European Commission's investigation into these airlines' codeshare agreement in the Brussels-Lisbon route, and TNT during the Turkish competition authority's investigation of TNT's agreements with its resellers.

Casilda's is significantly active in the field of litigation. Her recent experience includes assisting Renault in relation to damage claims following the CNMC's Article 101 decision in the car distribution sector. She has also been involved in other court and arbitration cases involving complex economic issues, such as abuse of dominance, intellectual property royalties, and regulated prices.
