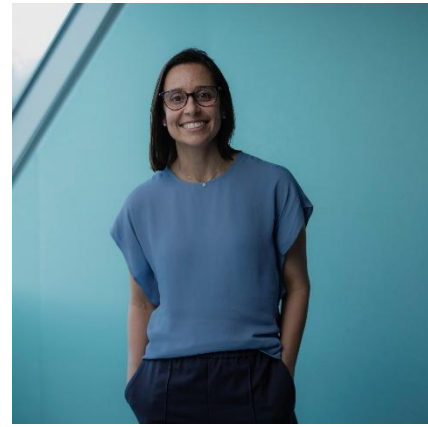
Ethel has also advised clients on other aspects of competition policy including market enquiries, abuse investigations, cartels and follow-on damages.
