"Once I'd expressed a desire to move abroad, the firm was quick to approve my transfer, which is something that might not happen in a larger organisation. When I started, I focused more on data analysis and commentary. I then turned to managing the day-to-day development of cases, writing reports and maintaining regular contact with clients and lawyers. Now I direct the economic analysis on high-profile cases before the European Commission. All through this process I was allowed to find my own path, while receiving guidance and encouragement from senior colleagues.

I particularly enjoy that there's no such thing as a typical day here. The sectors we work in change constantly, so no matter how senior you are you'll always be challenged intellectually.
