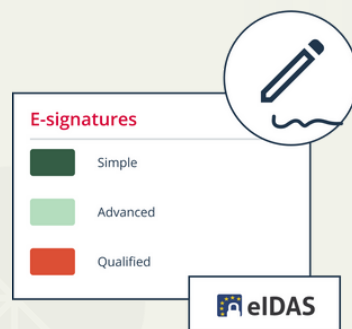

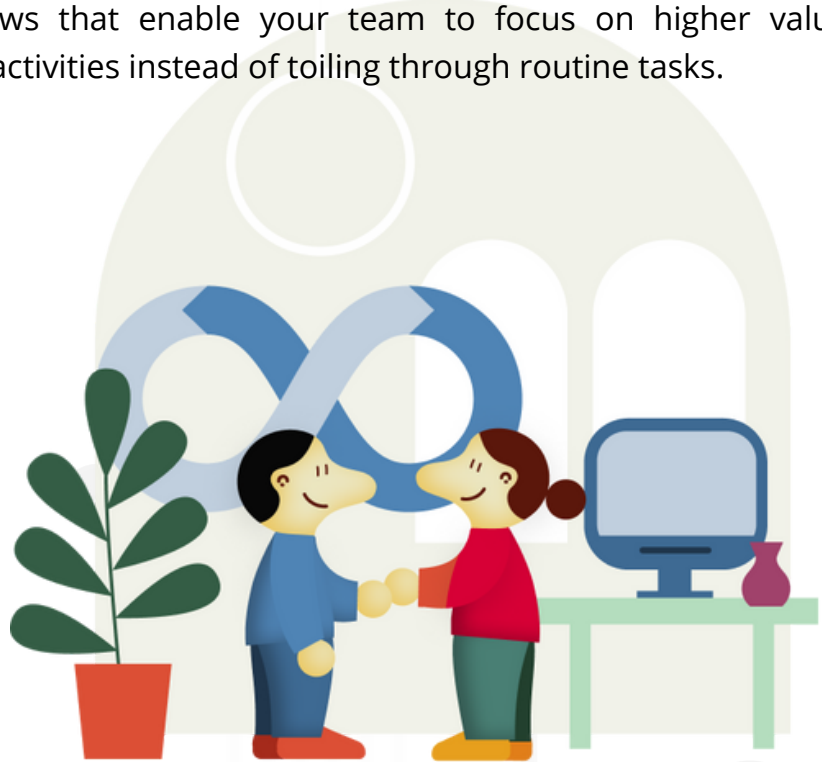

An audit trail keeps track of all access, and any changes to the content are automatically detected, so they can't affect the implementation of the agreement.



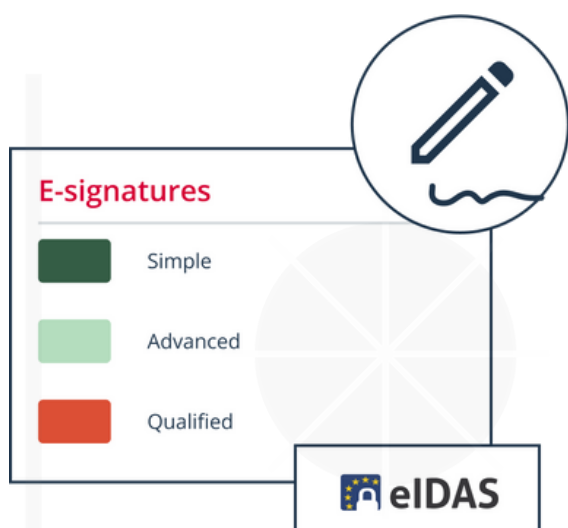

**The eIDAS Regulation, which stands for electronic identification and trust services for electronic transactions in the internal market, provides the legal guidelines for electronic signatures. It identifies three levels of assurance: low, medium, and high.**

InDoc EDGE users can pick between ordinary, advanced, and qualified electronic signatures. This way, users can choose the signature that best matches in terms of legal requirements and how risky it might be for someone to misuse the signer's identity.

You can confidentially share signed documents with signers and other stakeholders. As the process is fully traceable with a complete audit trail, which is nearly impossible with paper documents, users can easily perform post-signing compliance checks if needed.
