

PRIOR NOTICE OF AIRCRAFT MOVEMENT BOOKING FORM FOR AIRCRAFT OVER 15,000KG

Purpose of this Booking Form

This Booking Form should be completed where:

- you operate an aircraft over 15,000 kilograms (whether international or domestic); and
- you want to give us prior notice of your arrival at Canberra Airport, so that you are entitled to "Prior Notice" charges for landing and parking.

Application of reduced charges

The "Prior Notice" charges will only apply where:

- you have given us at least 24
 hours' notice of your arrival at
 Canberra Airport and provided all
 the information required by this
 Booking Form; and
- you have received from us written confirmation of receipt of this Booking Form, which will be by return email to you.
- If you receive written confirmation from us of a booking but the origin, destination or date/time has changed, you must submit to us an updated booking form and you

must receive our further written confirmation.

Note: A change of **arrival time** within the calendar day noted in the confirmed form will not necessitate a new booking form.

 subsequently significant details change including but not limited to date or arrival, aircraft details, if you do not meet these requirements, you will be charged at the rates which apply for "Unscheduled" aircraft movements.

Applicable conditions — If your aircraft lands at Canberra Airport, you are deemed to have accepted the Conditions of Use for Canberra Airport. Airport Conditions of Use are published on our website at canberraairport.com.au

This document includes the applicable landing and parking charges in Schedule 1. There are specific charges which apply for both "Prior Notice" and "Unscheduled" aircraft movements.

Note also that under the Conditions of Use, unless we agree otherwise, you must pay our charges before your aircraft leaves Canberra Airport.
