

Terms and Conditions

Trade Promotions - Games of Skill - Guess the Balls

These Terms and Conditions include terms that limit the Promoter's liability to you, entitle the Promoter to use your name, likeness and voice in connection with this Promotion and permit the Promoter to disclose your personal information to third parties (in accordance with the Promoter's Privacy Policy <https://www.canberraairport.com.au/privacy-policy>).

Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid. As a condition of accepting a prize, the winner must comply with all terms and conditions of use of a prize and with the directions of the Promoter's and any prize suppliers' representatives.

The following terms and conditions apply to the Guess the Balls promotion (**Promotion**) being conducted by Capital Airport Group Pty Limited ACN 080 711 191 of 21 Terminal Avenue, Plaza Offices - West, Canberra Airport ACT 2609 (**Promoter**).

Duration: The Promotion commences at 9.00am AEDT on 13/04/2026 and closes at 5.00pm AEDT on 11/05/2026 (**Promotional Period**).

Prize:

1. The **First Prize** consists of:

The total RRP value of the Second Prize is \$719. There is one Second Prize to be won.

3. Total RRP value of all prizes = \$2,878. All prize values are correct as at 09/05/2026 and are in Australian dollars.

Terms and Conditions

1. Entry is open to residents of ACT and NSW aged 18 years of age and over.
2. Employees and their immediate families of the Promoter, any prize drawers and any agencies, firms or companies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether biological or by adoption), parent, step-parent, grandparent, step- grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

- i. submit a response in 25 words or less to the following question: *why you would love a Viking Experience at the 31 May 2026 Game?*; and
 - ii. submit a response to the question: guess how many Raiders balls are in the Promotional Box.
4. Limit applies of one entry per person.
5. Entries must be received by the Promoter during the Promotional Period. Entries received after 11/05/2026 will not be accepted.
6. This Promotion is a game of skill. The closest answers (within a range of 10 above or below the correct answer) to guess the correct number of balls in the Promotional Box will be short listed for consideration by the Judging Panel.
7. The Winner will be determined by the Judging Panel, determining the best response to the question: *why you would love a Viking Experience at the 31 May 2026 Game?*
8. All short listed entries will be judged individually on their merits based on creativity. The best entry, as determined by the judges, will receive the First Prize. The second best entry, as determined by the judges, will receive the Second Prize. The judges' decision is final and binding - no correspondence will be entered into.
9. Judging will take place at 10am AEDT on 14/05/2026 at Level 4, Plaza Offices - West, 21 Terminal Avenue, Canberra Airport ACT 2609. Entries will be judged by a panel of judges from the Promoter.
10. All taxes (excluding GST) which may be payable as a consequence of receiving a prize are the sole responsibility of the winner.

In the event that a winner is unable to be contacted within 5 Business Days of being notified, or if the winner is ineligible or fails to comply with these conditions, the prize will be deemed forfeited. The Promoter reserves the right to re-distribute the prize in accordance with clause 19. The Promoter will not be liable for a winner that forfeits their prize and no correspondence has been entered into.

If still unresolved within a further 14 days of being escalated, then the senior Promoter manager will make a final and binding decision subject to any legal proceedings initiated by the complainant.
