



## Rate & Win Competition 2024 - Terms and Conditions

- Rating a Burger Wellington burger during the promotion period will automatically enter you into the draw for this competition.

### 1. The Promoter

1. Visa Wellington On a Plate and/or Wellington Culinary Events Trust will be known as 'The Promoter' within these terms and conditions.

### 2. Promotion Period

1. This competition commences at 9.00am Monday, 5 August 2024 and closes 11.59pm Sunday, 25 August 2024.

### 3. How to Enter

1. Log in or create a profile on VisaWOAP.com
2. Locate the listing for the Burger Wellington burger that you wish to rate.
3. Click the "RATE NOW" button under the image of the burger and slide the slider to your corresponding rating.
4. Every burger you rate will act as one entry to the competition. Please note The Promoter retains the right to verify the validity of entries and that the associated burger was consumed.

### 4. Major Prize

1. The major prize for this competition is a return trip for two to Singapore, courtesy of Singapore Airlines. This prize includes:
  - Return flights for two from Auckland International Airport to Singapore Changi Airport.
  - Return domestic transfers from any major domestic terminal to Auckland.
  - Five nights' stay in a Habitat Room with breakfast at Naumi Hotel Singapore.
