# **Big Issue Inflatable Soccer Event (the Event)**

# **Conditions of Entry**

The following terms and conditions apply to the Event being conducted by Canberra Airport Pty Limited ABN 14 080 361 548, Capital Airport Group Pty Limited ABN 52 080 711 191 and their related entities (Event Organiser):

- 1. The Event is a round-robin format soccer tournament, to be held on the grassed Town Square Oval in Brindabella Business Park (**Field**). Game rules and the default policy are available on the Airport Business Parks website (airportbusinessparks.com.au).
- 2. The Event will be held on Thursday, 2 November 2023 from 10:30am-2:30pm Australian Eastern Standard Time.
- 3. Entry is limited to teams comprising tenants of Brindabella Business Park, Majura Park and Fairbairn, Canberra Airport (**Airport Business Parks**) and those of their staff whose ordinary place of work is within the Airport Business Parks.
- 4. Entry to the Event is free.
- Teams must consist of no more than 5 team members per side. This includes 4 players and 1 goalkeeper. There are no substitutions. In the interests of diversity, we encourage all teams to include a range of genders.
- 6. Each team is required to register through Eventbrite by Friday, 27 October 2023. All team members' names and email addresses must be provided.
- 7. There will be prizes awarded to the team which accumulates:
  - (a) the most points
  - (b) the second most points
  - (c) the third most points

Points are awarded based on the number of goals the team scores with one point being awarded for each goal scored.

- 8. There will be prizes, as decided by the Event Organiser on the day, for:
  - (a) the best-dressed team
  - (b) the team exhibiting the best team spirit
- 8. All prize-winning teams will be required to provide proof that their members are tenants of or have their place of work within the Airport Business Parks as a condition precedent to receiving their prize.

9. The Event Organiser will be sole judge of any winner and their eligibility to receive a prize. All decisions and actions of the Event Organiser will be exercised according to its absolute discretion. In all matters, the decisions of the Event Organiser will be final and cannot be contested. No correspondence or discussions will be entertained.

# Participant acknowledgement

I agree that my participation in the Event is subject to my acknowledgement and acceptance of the terms and conditions of the release and indemnity and the privacy collection statement below.

# **Release and indemnity**

- 1. I am a tenant of the Airport Business Parks or a member of staff or employee of a tenant of the Airport Business Parks whose ordinary place of work is within the Airport Business Parks.
- 2. I understand that the Event is potentially hazardous to those taking part and I participate at my own risk.
- 3 I will not compete in the Event unless I am medically fit on the day of the Event.
- 4. I declare that I have undertaken sufficient training for the Event and that I am not aware of any illness, injury, physical disability or impairment which may cause me injury or death during or as a consequence of participation in the Event.
- 5. I accept full responsibility for informing myself and assessing all the dangers, hazards and risks of entry in the Event and will rely solely on my own assessment of these dangers, hazards and risks before participating in the Event and notwithstanding any decision made by the Event Organiser or other persons corporations and bodies involved in promoting or staging the Event. The decision to participate in the Event is entirely my own and I accept all risks associated with participation in the Event, including but not limited to loss of life and/or any injury (including any permanent injury).
- 6. I agree to abide by all Event terms and conditions. I understand that I must obey all directions and instructions given by representatives of the Event Organiser and the police.
- 7. I acknowledge that the Event Organiser and its representatives may remove me from the Event area and/or exclude me from participation in the Event if in their opinion it is necessary to do so:
  - (a) due to my behaviour being inappropriate, offensive, dangerous or abusive;
  - (b) to prevent damage or injury to any person or property; or
  - (c) on medical, health and/or safety grounds (including to prevent possible harm or injury to myself and/or any other person).
- 8. I consent to the Event Organiser using the personal details in my registration form for the administration of the Event, including to SMS information about the Event to me if I have provided a mobile phone number, unless otherwise indicated by me. I also consent to my personal details being used by the Event Organiser and its related bodies corporate for future marketing and promotional purposes.
- 9. In consideration of my entry to the Event, I agree on my own behalf and on behalf of my heirs, executors and administrators and declare that to the extent permitted by law, I waive

release and discharge each of the Event Organiser Parties (as defined in paragraph 10 below) from and against all and every claim, right or cause of action (including for negligence, for breach of contract or breach of statute) which I might have or which may arise out of my death or injury and/or damage or loss of any description which I may suffer or sustain as the result of or in connection with my participation in the Event. This release continues forever and binds my heirs, executors, personal representatives and assigns and may be pleaded as a bar to any action, claim, demand, suit or legal proceedings.

- 10. This waiver release and discharge operates jointly and severally in favour of the Event Organiser and its related bodies corporate, and their respective directors, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the Event, event stakeholders, the owners, licensees and occupiers of the land upon which the Event or any part of it is conducted, any statutory body or local authority having control over any land upon which the Event or any part of it is conducted, Event sponsors, supporters, persons, corporations, contractors, sub-contractors, volunteers, servants and employees involved or otherwise engaged in promoting, staging, administering, running or controlling the Event (the **Event Organiser Parties**).
- 11. Where a Participant is under the age of 18 years, in consideration of the Event Organiser agreeing at my request to accept the entry of this Participant in the Event, I hereby agree for myself, the Participant, their heirs, executors and administrators to hereby waive release and discharge (to the extent permitted by law) all and every claim, right or cause of action (including for negligence, for breach of contract or breach of statute) for which I might have or which the minor Participant may have or which arises out of the death, injury, damage or loss of any description which I or the Participant may suffer or sustain as a result of his/her participation in the Event. This release continues forever and binds the Participant's heirs, executors, personal representatives and assigns and may be pleaded as a bar to any action, claim, demand, suit or legal proceedings.
- 12. I consent to the publication and/or use in any form of media whatsoever of my name, result, image, voice, statement or otherwise, (including the publication of my name and/or Event result, suburb and applicable age bracket in any Event Organiser media publication or website) without any payment or compensation to me.
