

## 2026 Airport Community Fun Run (the Event)

### Terms and Conditions – Participant acknowledgement, release, indemnity and privacy

The following terms and conditions apply to the Event being conducted by Canberra Airport Pty Limited ABN 14 080 361 548, Capital Airport Group Pty Limited ABN 52 080 711 191 and their related entities (**Event Organiser**):

1. The Event is a foot-race/“fun-run” of approximately 5 kilometres in length, to be held over a course comprising sealed and natural surfaces in and around Canberra Airport (**Course**).
2. The Event will be held on Thursday 11 June 2026 at 12:00 midday Australian Eastern Time.
3. Entry to the Event is limited to tenants of Brindabella Business Park, Majura Park, Fairbairn, and Canberra Airport (**Airport Business Parks**) and those of their staff whose ordinary place of work is within the Airport Business Parks.
4. Entry to the Event is free.
5. To enter, each participant and/or team must visit <https://www.airportbusinessparks.com.au/events> and fully complete the online entry form, including full name, address, email address, telephone number. Teams are limited to 5 people.
6. Each participant is required to enter by Wednesday, 10 June 2026.
7. By registering for or participating in the Event, each participant agrees to be bound by these Terms.
8. This Event is a game of skill, not a game of chance.
9. Prizes will be awarded based on performance or judging criteria determined by the Event Organiser. There is a prize to be awarded to the winner of each of the following categories:

All prizes are subject to the terms and conditions of the third party supplier. The Promoter is not responsible or liable for any loss, damage or injury suffered by any winner as a result of the conduct of a supplier or otherwise as a result of the winner accepting and/or using a prize (even if caused by negligence), except to the extent the loss, damage or injury arises as a result of the fraud or wilful misconduct of the Event Organiser or its employees, officers, agents or contractors. Nothing in this clause limits any right to recourse you may have against the supplier of a prize.
11. The winner(s) will be notified in person and via SMS.
12. The collection of the prize is the responsibility of the winner(s). All reasonable attempts will be made to contact the winner(s). In the event that a winner is unable to be contacted within 3 months of being notified, or if the winner is ineligible or fails to comply with these conditions, the prize will be deemed forfeited. The Event Organiser will not be liable for a winner that forfeits their prize and no correspondence has been entered into.
13. Prizes are not transferable and cannot be exchanged for cash. The Event Organiser reserves the right to substitute a prize of greater or equal value if a prize becomes unavailable.
14. All prize winners will be required to provide proof of their tenancy at the Airport Business Parks or place of work within the Airport Business Parks as a condition precedent to receiving their prize.
15. The Event Organiser will be sole judge of any winner and their eligibility to receive a prize. All decisions and actions of the Event Organiser will be exercised according to its absolute discretion. In all matters, the decisions of the Event Organiser will be final and cannot be contested. No correspondence or discussions will be entertained.
16. The participant warrants they are a tenant of the Airport Business Parks or a member of staff or employee of a tenant of the Airport Business Parks whose ordinary place of work is within the Airport Business Parks.
17. The participant acknowledges and understands that the Event is potentially hazardous to those taking part. Participation in the Event is voluntary and the participant is participating at their own risk.
18. The participant warrants they are physically and medically fit to participate in the Event and have not been advised otherwise by a medical practitioner. The participant declares they have undertaken sufficient training for the Event and they are not aware of any illness, injury, physical disability or impairment which

may cause them injury or death during or as a consequence of participation in the Event.

19. The participant accepts full responsibility for informing themselves and assessing all the dangers, hazards and risks of entry in the Event and will rely solely on their own assessment of these dangers, hazards and risks before participating in the Event and notwithstanding any decision made by the Event Organiser or other persons corporations and bodies involved in promoting or staging the Event. The decision to participate in the Event is entirely their own and they accept all risks associated with participation in the Event, including but not limited to loss of life and/or any injury (including any permanent injury).
20. The participant must follow the approved course and obey all directions and instructions given by representatives of the Event Organiser and the police.
21. The participant acknowledges that the Event Organiser and its representatives may remove them from the Event area and/or exclude them from participation in the Event if in their opinion it is necessary to do so:
  - (a) due to their behaviour being inappropriate, offensive, dangerous or abusive;
  - (b) to prevent damage or injury to any person or property; or
  - (c) on medical, health and/or safety grounds (including to prevent possible harm or injury to them and/or any other person).
22. The participant consents to the Event Organiser using the personal details in their registration form for the administration of the Event, including to SMS information about the Event to the participant if they provided a mobile phone number, unless otherwise indicated by the participant. The participant also consents to their personal details being used by the Event Organiser and its related bodies corporate for future marketing and promotional purposes.
23. In consideration of their entry to the Event, the participant agrees on their behalf and on behalf of their heirs, executors and administrators and declare that to the extent permitted by law, they waive release and discharge each of the Event Organiser Parties (as defined in paragraph 10 below) from and against all and every claim, right or cause of action (including for negligence, for breach of contract or breach of statute) which they might have or which may arise out of their death or injury and/or damage or loss of any description which they may suffer or sustain as the result of or in connection with their participation in the Event. This release continues forever and binds their heirs, executors, personal representatives and assigns and may be pleaded as a bar to any action, claim, demand, suit or legal proceedings.
24. This waiver release and discharge operates jointly and severally in favour of the Event Organiser and its related bodies corporate, and their respective directors, officers, agents, contractors, employees and volunteers including medical and paramedical personnel appointed for the Event, event stakeholders, the owners, licensees and occupiers of the land upon which the Event or any part of it is

conducted, any statutory body or local authority having control over any land upon which the Event or any part of it is conducted, Event sponsors, supporters, persons, corporations, contractors, sub-contractors, volunteers, servants and employees involved or otherwise engaged in promoting, staging, administering, running or controlling the Event (the **Event Organiser Parties**).

25. Where a participant is under the age of 18 years, in consideration of the Event Organiser agreeing at my request to accept the entry of this participant in the Event, the participant hereby agrees (in relation to the participant, their heirs, executors and administrators) to waive release and discharge (to the extent permitted by law) all and every claim, right or cause of action (including for negligence, for breach of contract or breach of statute) for which they may have or which the minor participant may have or which arises out of the death, injury, damage or loss of any description which they may suffer or sustain as a result of his/her participation in the Event. This release continues forever and binds the participant's heirs, executors, personal representatives and assigns and may be pleaded as a bar to any action, claim, demand, suit or legal proceedings.
26. The participant consents to the publication and/or use in any form of media whatsoever of their name, result, image, voice, statement or otherwise, (including the publication of their name and/or Event result, suburb and applicable age bracket in any Event Organiser media publication or website) without any payment or compensation to them.
27. The Event Organiser collects personal information for the administration of the Event and for future marketing and promotional purposes relating to Canberra Airport and the Event Organiser's group of companies.
28. The Event Organiser may:
  - (a) disclose and use the participant's personal information in accordance with the Event Organiser's privacy policy available at <https://www.canberraairport.com.au/privacy-policy> and in accordance with these Event terms and conditions; and
  - (b) disclose the participant's personal information to its related bodies corporate and any third parties involved in the Event, including service providers.
29. Further information on how the Event Organiser handles personal information is contained in the Event Organiser's Privacy Policy.
30. These terms will be governed by and construed in accordance with the laws of the Australian Capital Territory.
31. If any provision of the terms is found by a proper authority to be unenforceable or invalid, such unenforceability or invalidity will not render the terms unenforceable or invalid as a whole and, in such event, such provision will be changed and interpreted to best accomplish the objectives of such unenforceable or invalid provision within the limits of applicable law or applicable court decisions.
