

Terms & Conditions

1. Attendance by a particular player, athlete or team member is not guaranteed. The appearance may include some, but not necessarily all, players from ACT Brumbies. Participation is subject to availability, team commitments, travel schedules and operational requirements.
2. The lunch and learn experience is for a limited time only and may be shortened, delayed or rescheduled due to operational, safety or crowd management reasons.
3. This event is subject to registration availability and venue capacity. A valid ticket or confirmed registration is required for entry. Entry may be refused once capacity is reached, even if registration has been submitted.
4. Attendees must follow instructions from event staff, security and site management. Failure to do so may result in refusal of participation.
5. There is no guarantee of one-on-one interaction, extended conversation or repeat engagement with players or representatives.
6. Audience participation, including questions and interaction, may be limited or moderated at the discretion of the event Organiser.
