SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. To develop a plan for our ARP funds, we engaged a diverse set of stakeholders that represent the students we will serve with these funds. We accomplished this by providing a survey seeking the input of our stakeholders, including families, staff and faculty, and school leadership, on the use of our funds. The survey included an opportunity for respondents to express their priorities for supporting students as they return to school after COVID-19. The survey was sent to our community in November 2021, including parents and staff, as well as other stakeholders such as The Door. In addition, we posted a link to the survey on our website, allowing for anyone to contribute feedback. We used the results of this survey to design our plan for spending ARP funds.

Our ARP grant is largely for tutors to remediate learning loss and provide social-emotional support. Therefore, other grants besides ARP have dealt more with CDC guidance.

As part of the implementation of our cohort model, we monitor the progress of our students throughout the year and design appropriate interventions if growth toward academic goals is not being accomplished. Our Academic Deans meet weekly to review student data and identify the needs of our SWD.

Inherent in our model is an emphasis on social-emotional health. Our social work department includes a Director of Social Work, four Social Workers (including the Attendance Social Worker) and two School Counselors. The special education and social work departments collaborate closely to support students at BSA. Often, students receiving counseling have been referred to the Director of Special Education to be evaluated for a 504 plan. Nearly three-quarters of our students with IEPs have mandated counseling.

A portion of our 2020 summer school program and the summer bridge program for incoming first-year students covered self-management skills to support returning to in-person learning, such as how to prioritize emails, how to ask a teacher for help, and how to set a schedule.

We closely track the progress of students receiving interventions and adjust student plans accordingly.

5. We are allocating our entire ARP allocation to implement a robust tutoring program through Great Oaks. Great Oaks provides Americore tutors to be staffed at our school to help our students recover from learning loss in areas including ELA, math, other core subjects, and community-building. There is extensive research demonstrating the positive academic effects associated with high-dosage tutoring and peer-assisted learning strategies. By providing students with access to 17-20 dedicated tutors over the course of the school year, we are confident that working with Great Oaks will address learning loss and improve outcomes for all of our students, including students with disabilities, English language learners, low-income students, and other at-risk groups.

Our staff members are committed to supporting all students, including our students disproportionately impacted by the COVID-19 pandemic, with the transition back to in-person learning. We will ensure that the interventions we implement, including but not limited to the interventions implemented under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time, will respond to the academic, social, emotional, and mental health needs of all students, and particularly those students disproportionately impacted by the COVID19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students.

Please see a summary of the needs we are addressing.

Through our unique partnership with The Door, all BSA students have had access to the services offered by The Door, all at no cost and in the same building as their school. These services include: primary and reproductive health care and education, mental health counseling and crisis assistance, legal assistance, academic and college-preparatory services, career development, job training and placement, supportive housing, sports and recreational activities, arts programming, and daily nutritious meals.

· Academic needs for at-risk students:

At least half of our students each year are either classified as a student with a disability (SWD) or an English language learner (ELL) or, though not qualifying for an IEP, receive targeted academic interventions.

BSA uses an inclusive approach and cohort model. As part of the implementation of our cohort model, we monitor the progress of our SWD, ELLs, and students at risk for academic failure throughout the year and design appropriate interventions if progress toward academic goals is not satisfactory. Our cohort leaders meet weekly to review student data and identify the needs of our students. Sometimes, data trends indicate a need for a more structural shift. For example, prior years' Algebra Regents outcomes informed our decision to introduce a two-year course for Algebra in 2019-20. This supports students who need more time in Algebra for a variety of reasons and helps them pass the Regents Algebra exam at a point at which they are fully prepared to take the exam.

Our capacity to design, implement, and measure the success of supports for at-risk students is facilitated by our organizational structure. The Dean of Diversity, Equity, and Inclusion leads a team of special education-certified teachers and a full-time Math Tutor. This position provides one-on-one math tutoring for students with IEPs. We follow a codified Response to Intervention (RTI) model and use PowerSchool to track student data in the RTI cycle.

Caregiver communication is an important element in our approach to supporting SWD, ELLs, and at-risk students. We proactively update caregivers on their students' progress and ensure ongoing engagement through periodic and meaningful contacts throughout the school year, including IEP reevaluation meetings, and yearly IEP review meetings.

- Social-emotional needs for at-risk students: BSA implements "the CHAMPION Model," which pairs every staff member with a group of students to develop relationships and build problem-solving, self-advocacy and self-efficacy skills. This program includes our advisory period, which is critical to supporting students' social-emotional health.
- · Mental health needs for at-risk students:

BSA's population includes many students who are most at-risk for dropping out of high school. For a majority of our students, their personal day-to-day circumstances can cause a substantial amount of trauma that must be addressed to fully support our students' success at BSA. We know they need more than a responsive academic program. Our social work department includes a Director of Social Work, four Social Workers (including the Attendance Social Worker) and two School Counselors. Our approach to social work at BSA is rooted in data and evidence-based practice. Since 2017, BSA has administered a research-based survey developed specifically to identify students' mental health needs. We use the results of this data both to identify students in need of counseling and to track the progress of students receiving counseling. BSA provides both mandated and non-mandated counseling for students through our social work department, (both short-term and long-term). In addition, BSA refers students for
