The meeting was called to order at 5:06pm, with a quorum.

<u>Introduction of William Murdock, Proposed New Board Member</u>

Mr. Zurndorfer introduced William Murdock, Head of Special Opportunities in Investment Banking at Lazard. In this role, Mr. Murdock is a member of Lazard's Special Opportunities Group, a highly selective, multidisciplinary advisory team that reports directly to and supports the CEO on high-impact investment banking assignments, internal strategic initiatives, corporate development, and thought leadership. Prior to joining Lazard, he completed an Economics PhD at Harvard University and was as a research analyst at the Education Innovation Laboratory at Harvard University.

Approval of the Minutes

The Board voted unanimously to approve the minutes of the May 21, 2024, Board Meeting.

Approval of the Budget for the 2024-2025 School Year

Mr. Berry reported on the proposed FY24-25 budget. The Finance Committee reviewed the budget against the approved FY24 budget and FY24 year-end projections. The FY24 budget assumed a \$30k surplus before depreciation and we are projecting a year-end \$10k surplus. The FY25 proposed budget is based on the enrollment of 290 scholars. The FY25 budget has a \$417k deficit against \$8.3M in expenses. The Finance Committee recommended that the Board approve the proposed FY25 budget.

The Board unanimously approved the FY2024-2025 budget.

Head of School Report

Ms. Ford presented the Head of School report.

Ms. Ford reported on scholar enrollment and current students' intent to return as of June 15:

- 9th grade scholars
 - o Returning to BSA: 20
 - Not returning: 11
 - o Unsure: 0
 - Needs follow up: 7
- 10th grade scholars

Returning to BSA: 27

Not returning: 2

• 12th grade intent to return is to be determined as BSA is finalizing graduation data for June and August. Currently, 38 scholars are on track to graduate at the end of the school year.

As of June 15, BSA completed four scholar registrations and an additional 13 registrations are in progress.

Ms. Ford provided an update on attendance from December 2023 through May 2024. Attendance at BSA continues a positive trajectory with a six-month average of 88% of scholars coming to school each day. The highest daily attendance percentage was 94%; the lowest percentage was 72%.

BSA scholar utilization of Door services from September 6, 2023, through May 31, 2024, shows the following:

- 30 BSA scholars completed the Door membership process, making the total percentage of scholars with Door IDs 69% (219 out of 317)
- 120 unduplicated scholars accessed 952 Door services with the following programming reporting the highest usage:
 - 87 scholars received 247 healthcare-related services through the Door
 - o 94 scholars received 447 food and pantry services
 - 39 scholars engaged in 125 group and arts-related services
 - 25 BSA scholars received 61 housing and emergency services through the Door's Runaway Homeless Youth program
