This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The My Select life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the Higher fund manufactured by Scottish Friendly, and links to a range of Legal & General Index Trusts. Scottish Friendly is authorised by the Prudential Regulation Authority and regulated by the Financial Conduct Authority and the Prudential Regulation Authority. What is this product?

Type The product is a unitised whole of life assurance policy held within the Scottish Friendly Junior

ISA with a chosen investment option of the Higher insurance fund.

Objectives My Select is a unit linked whole of life assurance policy that aims to help your investments

to grow tax-efficiently. The chosen investment option of the Higher fund aims to achieve growth from a mixed investment, which may include the UK and global stock market, cash, government and company bonds. It tends to focus on those assets with higher levels of risk and return, such as UK and international stock market assets, to match the historic level of risk associated with investing in the UK stock market. This does not mean that the fund will track or act like the UK stock market, only that an investor could expect a similar level of risk from this fund should its historic performance be repeated. Tax treatment depends on individual

circumstances and can change in the future.

Maturity This product matures when the child reaches age 18. The recommended holding period is at

least 5 years. Scottish Friendly cannot unilaterally terminate this product.

This product is intended for investors who are prepared to take on a medium level of risk, in a

mixed asset investment, in a medium to long-term arrangement.

Insurance benefit The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could the child get in return



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you transfer to another provider or the child cashes in at an early stage and they may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay the child.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact our capacity to pay them.

The product does not include any protection from future market performance so the child could lose some or all of the investment. If we are not able to pay the child what is owed, they could lose the entire investment. However, they may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that your child may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in a range of assets, which may include Equities (shares in companies), cash, Government and Corporate Bonds (loans to governments or companies) therefore the performance of each of these assets will impact the performance of the fund. The majority of the assets are Equities (shares in companies) from the UK and around the world therefore the performance of these assets will have a large impact on the returns investors will receive for the child. It is expected, before charges, that the returns would be comparable to the UK stock market.

What could affect my return positively?

As the majority of the assets are equities, strong economic performance, where the economy is growing, within the UK and globally would likely lead to a positive outcome for investors. Where companies from the UK and globally perform well resulting in their share prices increasing, these would likely lead to a positive outcome for investors.

What could affect my return negatively?

Poor economic performance also known as a recession impacting companies from the UK and globally, resulting in falling share prices would negatively impact the returns. Under severely adverse conditions returns of the fund could be impacted negatively meaning investments in the fund could fall significantly in value. Your child's maximum loss would be that they lose all of their investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, the child may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return the child might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. Within the first 5 years of setting up the policy, if it is transferred by the registered contact to another Junior ISA manager, or if the child turns 18 and requests a withdrawal which would leave a value of less than £50 in their policy, there will be a £50 deduction from the child's plan.
