Purpose

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The My Select life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the UK Government Bond fund, which is manufactured by Scottish Friendly, and links to the Legal and General All Stocks Gilt Index. What is this product?

Type The product is a unitised whole of life assurance policy held within the Scottish Friendly Junior

ISA with a chosen investment option of the UK Government Bond insurance fund.

Objectives My Choice is a unit linked whole of life assurance policy that aims to help your investments

to grow tax-efficiently. The chosen investment option of the UK Government Bond fund aims to generate capital growth over the medium to long term by investing in bonds (gilts) issued by the UK Government. It invests in an underlying fund that investment in gilts with varying length of terms, with an average term of more than 5 years. The funds performance will be dependent on the credit worthiness of the UK Government and the movement in long-term interest rates, which can raise or lower the value of bonds held in the fund and the child could get back less than you pay in. Tax treatment depends on individual circumstances and can

change in the future.

Maturity This product matures when the child reaches age 18. The recommended holding period is at

least 5 years. Scottish Friendly cannot unilaterally terminate this product.

Intended retail

This product is intended for investors who are prepared to take on a medium-low level of risk,

investor linked to an index of bonds issued by the UK Government, in a medium to long-term arrangement.

Insurance benefit The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could the child get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you transfer to another provider or the child cashes in at an early stage and they may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay the child.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact our capacity to pay them.

The product does not include any protection from future market performance so the child could lose some or all of the investment. If we are not able to pay the child what is owed, they could lose the entire investment. However, they may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that your child may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in UK Government Bonds, known as Gilts, (loans to the government) therefore changes to long term interest rates and the credits worthiness (credit rating) of the UK can have a significant impact on returns. Changes to these can raise or lower the value of bonds held and the return received. The fund is expected to perform in line with major UK Gilt indices.

What could affect my return positively?

The credit worthiness of the UK Government being strong and higher long term interest rates could lead to positive returns.

What could affect my return negatively?

Negative changes to the credit worthiness of the UK Government and changes to long term interest rates could negatively impact returns of the fund. Under severely adverse conditions returns of the fund could fall significantly in value. Your childs maximum loss would be that they lose all of their investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, the child may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return the child might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. Within the first 5 years of setting up the policy, if it is transferred by the registered contact to another Junior ISA manager, or if the child turns 18 and requests a withdrawal which would leave a value of less than £50 in their policy, there will be a £50 deduction from the child's plan.
