Purpose

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The My Choice life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the UK Government Bond fund, which is manufactured by Scottish Friendly, and links to the Legal and General All Stocks Gilt Index. What is this product?

Type The product is a unitised whole of life assurance policy held within the Scottish Friendly Junior

ISA with a chosen investment option of the UK Government Bond insurance fund.

Objectives My Choice is a unit linked whole of life assurance policy that aims to help your investments

to grow tax-efficiently. The chosen investment option of the UK Government Bond fund aims to generate capital growth over the medium to long term by investing in bonds (gilts) issued by the UK Government. It invests in an underlying fund that investment in gilts with varying length of terms, with an average term of more than 5 years. The funds performance will be dependent on the credit worthiness of the UK Government and the movement in long-term interest rates, which can raise or lower the value of bonds held in the fund and the child could

get back less than you pay in. ISA and tax rules may change in the future.

Maturity This product matures when the child reaches age 18. The recommended holding period is at

least 5 years. Scottish Friendly cannot unilaterally terminate this product.

Intended retail investor This product is intended for investors who are prepared to take on a lower to medium-low level

of risk, linked to an index of bonds issued by the UK Government, in a medium to long-term

arrangement.

Insurance benefit The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could the child get in return?





The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you transfer to another provider or the child cashes in at an early stage and they may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay the child.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact our capacity to pay them.

The product does not include any protection from future market performance so the child could lose some or all of the investment. If we are not able to pay the child what is owed, they could lose the entire investment. However, they may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that your child may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in Global Equities (shares in companies) therefore the performance of companies from around the world will have a significant impact on returns. The majority of the equities held are from the United States therefore the returns received could be expected to be influenced by the overall performance of the United States. It is expected before charges that the returns would be comparable to the Vanguard ESG Developed World All Cap Equity Index Fund which performance of the fund is measured against.

What could affect my return positively?

Strong economic performance within the United States and developed countries from around the world would likely lead to a positive outcome for investors. Where companies from the United States and around the developed world perform well resulting in their share prices increasing this would likely lead to a positive outcome.

What could affect my return negatively?

Poor economic performance also known as a recession impacting companies resulting in falling share prices would negatively impact the returns especially within the United States and from other developed countries around the world. Under severely adverse conditions returns of the fund could be substantially negative meaning investments in the fund could fall substantially in value. Your child's maximum loss would be that they lose all of their investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, the child may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return the child might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. The registered contact can transfer to another Junior ISA manager at anytime, and when the child turns 18 they can access the money.
