Product

The My Choice life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the International Ethical fund, which is manufactured by Scottish Friendly, and links to the Vanguard ESG Developed World All Cap Equity Index Fund (UK). What is this product?

| Type | The product is a unitised whole of life assurance policy held within the Scottish Friendly ISA with a chosen investment option of the International Ethical insurance fund. |
| Objectives | My Choice is a unit linked whole of life assurance policy that aims to help your investments to grow tax-efficiently. The chosen investment option of the International Ethical fund aims to generate capital growth by investing in the shares of companies or investments linked to the shares of companies throughout the world that have minimal, if any, direct exposure to Controversies (i.e. against the UN Global Compact Principles), Non-renewable energy (Fossil Fuel and Nuclear Power), Vice products (Adult Entertainment, Alcohol, Gambling and Tobacco) and Weapons. It invests in an underlying fund with the intention of passively managing a portfolio of shares issued by companies. The fund's performance will be dependent on the performance of the shares purchased, held and sold by the fund manager, the movement in global stock markets and the movement in currency exchange rates. ISA and tax rules may change in the future. |
| Maturity | This product does not have a maturity date. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product. |
| Intended retail investor | This product is intended for investors who are prepared to take on a medium level of risk, linked to an index that includes global companies but with no or minimal exposure non-renewable energy, adult entertainment, alcohol, gambling, tobacco or weapons and companies that do not meet the UN Global Compact Principles, in a medium to long-term arrangement. |
| Insurance benefit | The amount payable on death is 101% of the value of units held within the policy. |

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level and poor market conditions could impact our capacity to pay you.

The product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in Global Equities (shares in companies) therefore the performance of companies from around the world will have a significant impact on returns. The majority of the equities held are from the United States therefore the returns received could be expected to be influenced by the overall performance of the United States. It is expected before charges that the returns would be comparable to the Vanguard ESG Developed World All Cap Equity Index Fund which performance of the fund is measured against.

What could affect my return positively?

Strong economic performance within the United States and developed countries from around the world would likely lead to a positive outcome for investors. Where companies from the United States and around the developed world perform well resulting in their share prices increasing this would likely lead to a positive outcome.

What could affect my return negatively?

Poor economic performance also known as a recession impacting companies resulting in falling share prices would negatively impact the returns especially within the United States and from other developed countries around the world. Under severely adverse conditions returns of the fund could be substantially negative meaning investments in the fund could fall substantially in value. Your maximum loss would be that you lose all of your investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.
