

# Key Information Document



## Purpose

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## Product

The My Select life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The investment option is the Lower fund manufactured by Scottish Friendly, and links to a range of Legal & General Index Trusts. ## What is this product?

<b>Type</b>	The product is a unitised whole of life assurance policy held within the Scottish Friendly Junior ISA with a chosen investment option of the Lower insurance fund.
<b>Objectives</b>	My Select is a unit linked whole of life assurance policy that aims to help your investments to grow tax-efficiently. The chosen investment option of a Lower fund aims to achieve long-term growth from a mixed investment, which may include the UK and global stock markets, cash government and company bonds. It will focus on those assets with historically lower levels of risk and expected return, such as cash and bonds, to match the historic level of risk associated with investing in UK Government bonds. This does not mean that the fund will track or act like UK Government bonds, only that an investor could expect a similar level of risk from this fund should its historic performance be repeated. ISA and tax rules may change in the future.
<b>Maturity</b>	This product matures when the child reaches age 18. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product.
<b>Intended retail investor</b>	This product is intended for investors who are prepared to take on a medium-low level of risk, from a mixed asset investment, in a medium to long-term arrangement.
<b>Insurance benefit</b>	The amount payable on death is 101% of the value of units held within the policy.

## What are the risks and what could the child get in return?-low



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you transfer to another provider or the child cashes in at an early stage and they may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay the child.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions could impact our capacity to pay them.

The product does not include any protection from future market performance so the child could lose some or all of the investment. If we are not able to pay the child what is owed, they could lose the entire investment. However, they may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

## Performance scenarios

When money is invested it is exposed to risk, meaning that your child may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in a range of assets, which may include Equities (shares in companies), cash, Government and Corporate Bonds (loans to governments or companies) therefore the performance of each of these assets will impact the overall performance of the fund. The majority of the assets are Government and Corporate bonds and therefore the performance of these assets will have a large impact on the returns investors will receive for the child. It is expected, before charges, that the returns would be comparable to UK Government Bonds.

### What could affect my return positively?

As the majority of assets are bonds, the credit worthiness of the companies and governments issuing the bonds held within the fund will have a significant impact on the fund's performance. Long-term interest rates from the countries the bonds are from will impact on the fund's performance.

### What could affect my return negatively?

A fall in credit worthiness could lead to companies and government not being able to repay their loans and could have a significant impact on the fund's performance. Under severely adverse conditions returns of the fund could be impacted negatively meaning investments in the fund could fall substantially in value. Your child's maximum loss would be that they lose all of their investment.

## What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, the child may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return the child might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

### How long should I hold it and can I take money out early?

#### Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. Within the first 5 years of setting up the policy, if it is transferred by the registered contact to another Junior ISA manager, or if the child turns 18 and requests a withdrawal which would leave a value of less than £50 in their policy, there will be a £50 deduction from the child's plan.
