What is this product?

| Objectives | The UK Equity Fund predominately provides exposure to companies which are based in the UK. To achieve this the fund will invest in one or more funds which are Managed by Schroder's. The fund aims to provide capital growth and aims to provide returns in excess of the returns of major market indices which covers the United Kingdom, before charges. Investments can be from across all industries and may also invest in money market instruments. The fund may also use financial instruments, for instance derivatives, with the aim of reducing risk and/or managing the fund more efficiently. As with all investments there is risk with investing and the value of your investments may fall as well as rise, however these are not guaranteed, therefore you may get back less than has been paid in. |
| Maturity | This product does not have a maturity date. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product. |
| Intended retail investor | This product is intended for investors who are prepared to take on a medium level of risk, linked to the performance of the UK stock market, in a medium to long-term arrangement. |
| Insurance benefit | The amount payable on death is 101% of the value of units held within the policy. |

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in UK Equities (shares in companies) therefore the performance of companies from the UK will have a significant impact on returns. The majority of the equities held are from the UK therefore the returns received could be expected to be influenced by the overall performance of the UK. It is expected, before charges, that the returns would be comparable to the UK stock market against which the performance of the fund is measured.

What could affect my return positively?

Strong economic performance, where the economy is growing, within the UK would likely lead to a positive outcome for investors. Where companies from the UK perform well resulting in their share prices increasing this would likely lead to a positive outcome.

What could affect my return negatively?

Poor economic performance also known as a recession impacting companies from the UK, resulting in falling share prices would negatively impact the returns. Under severely adverse conditions returns of the fund could be negative meaning investments in the fund could fall significantly in value. Your maximum loss would be that you lose all of your investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.
