This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The My Select ISA life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The Investment option is the UK Government Bond Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders. What is this product?

Type The Investment option is the UK Government Bond Fund which is manufactured by Scottish

Friendly, and links to 1 or more funds managed by Schroders.

Objectives The UK Government Bond Fund predominately provides exposure to UK Government Bonds

(Gilts), also known loans to the UK Government. To achieve this the fund will invest in one or more funds which are managed by Schroders. The fund aims to provide capital growth and aims to provide returns in excess of the returns of major market indices which covers UK Government Bonds, before charges. Investments can be from across all industries and may also invest in money market instruments. The fund may also use financial instruments, for instance derivatives, with the aim of reducing risk and/or managing the fund more efficiently. As with all investments there is risk with investing and the value of your investments may fall as well as rise, however these are not guaranteed, therefore you may

get back less than has been paid in.

Maturity This product does not have a maturity date. The recommended holding period is at least 5

years. Scottish Friendly cannot unilaterally terminate this product.

This product is intended for investors who are prepared to take on a medium-low level of risk, by having exposure to bonds issued by the UK Government, in a medium to long-term

arrangement.

Insurance benefit The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could I get in return?

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in UK Government Bonds, known as Gilts, (loans to the government) therefore changes to long term interest rates and the credits worthiness (credit rating) of the UK can have a significant impact on returns. Changes to these can raise or lower the value of bonds held and the return received. The fund is expected to perform in line with major UK Gilt indices.

What could affect my return positively?

The credit worthiness of the UK Government being strong, or positive changes to the credit worthiness of the UK Government, and changes to the long term interest rates could lead to positive returns for the fund.

What could affect my return negatively?

Negative changes to the credit worthiness of the UK Government and changes to long term interest rates could negatively impact returns of the fund. Under severely adverse conditions returns of the fund could fall significantly in value. Your maximum loss would be that you lose all of your investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. You have access to your money at all times but if you make a withdrawal within the first 5 years a £50 deduction applies.
