## **Purpose**

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

#### Product

# What is this product?

**Type**The Investment option is the Global High Yield Fixed Interest Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders.

**Objectives**The Global High Yield Fixed Interest Fund predominately provides exposure to bonds which

are below investment grade worldwide. Although the fund can invest worldwide the fund is hedged to UK Sterling which means it is primarily not impacted by changes in currency. To achieve this the fund will invest in one or more funds. The fund aims to provide capital growth and aims to provide returns in excess of the returns of a market indices which cover the Global High Yield Bonds, before charges. Investments can be from across all industries and bonds issued by governments, government agencies, supra-nationals and companies worldwide. The fund may also use financial instruments, for instance derivatives, with the aim of reducing risk and/or managing the fund more efficiently. As with all investments there is risk with investing and the value of your investments may fall as well as rise,

however these are not guaranteed, therefore you may get back less than has been paid in.

This product does not have a maturity date. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product.

Intended retail

This product is intended for investors who are prepared to take on a high level of risk, linked to a portfolio of bonds issued throughout the world which are consider below investment

grade, selected by an expert fund manager, in a medium to long-term arrangement.

**Insurance benefit** The amount payable on death is 101% of the value of units held within the policy.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.



Maturity

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

#### Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in Corporate Bonds (loans to companies) from around the world. The funds performance will be dependent on the credit worthiness of the company bonds purchased by the fund manager. Movements in long-term interest rates and the movement in currency exchange rates will also impact the fund's performance. The long term interest rates from around the world will have a significant impact on the fund's performance.

# What could affect my return positively?

The credit worthiness of the company issuing the bonds held within the fund will have a significant impact on the fund's performance. The long-term interest rates from around the world will have an impact on the fund's performance.

## What could affect my return negatively?

A fall in credit worthiness could lead to companies not being able to repay their loans and would have a significant impact on the fund's performance. Changes to the long-term interest rates around the world may have an impact on the fund's performance. Under severely adverse conditions returns of the fund could be significantly negative meaning investments in the fund could fall substantially in value. Your maximum loss would be that you lose all of your investment.

## What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

#### What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.
