## Purpose

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

## Product

The My Select ISA life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The Investment option is the Mixed Asset: Defensive Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders. ## What is this product?

<b>Type</b>	The Investment option is the Mixed Asset: Defensive Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders.
<b>Objectives</b>	The Mixed Asset: Defensive Fund predominately invests in one or more fund funds which are managed by Schroders. The Fund is designed to provide long term capital growth and income, together with a low level of investment risk. The fund invests, either directly or indirectly, in a diversified portfolio of fixed interest securities, equities, alternatives and property. The portfolio will be actively managed relative to its designated benchmark and seeks to outperform its benchmark through active stock selection and asset allocation. The portfolio is designed to participate in the ABI Mixed Investment 0-35% shares peer group. The value of Investments within the fund may fall and rise and a positive return is not guaranteed, therefore you may get back less than was paid in.
<b>Maturity</b>	This product does not have a maturity date. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product.
<b>Intended retail investor</b>	This product is intended for investors who are prepared to take on a medium-low level of risk, from a mixed asset investment, in a medium to long-term arrangement.
<b>Insurance benefit</b>	The amount payable on death is 101% of the value of units held within the policy.

## What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

If we are not able to pay you what is owed, you could lose your entire investment. However, you may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

## Performance scenarios

When money is invested it is exposed to risk, meaning that you may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in a range of assets, which may include Government and Corporate Bonds (loans to governments or companies), equities (shares in companies) and cash therefore the performance of each of these assets will impact the overall performance of the fund. The majority of the assets are Government and Corporate bonds and therefore the performance of these assets will have a large impact on the returns investors will receive. It is expected, before charges, that the returns would be comparable to UK Government Bonds.

### What could affect my return positively?

As the majority of assets are bonds, the credit worthiness of the companies and governments issuing the bonds held within the fund will have a significant impact on the fund's performance. Long-term interest rates from the countries the bonds are from will impact on the fund's performance.

### What could affect my return negatively?

A fall in credit worthiness could lead to companies and government not being able to repay their loans and could have a significant impact on the fund's performance. Under severely adverse conditions returns of the fund could be impacted negatively meaning investments in the fund could fall substantially in value. Your maximum loss would be that you lose all of your investment.

### What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, you may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

### What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

### How long should I hold it and can I take money out early?

#### Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. You have access to your money at all times but if you make a withdrawal within the first 5 years a £50 deduction applies.
