Purpose

This document provides you with the key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

The My Select JISA life policy, is manufactured by Scottish Friendly Assurance Society Limited ('Scottish Friendly'). The Investment option is the Climate Leaders Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders. What is this product?

Type

The Investment option is the Climate Leaders Fund which is manufactured by Scottish Friendly, and links to 1 or more funds managed by Schroders.

Objectives

The Climate Leaders Fund predominantly invests in the Schroder ISF Global Climate Leaders Fund.

The fund aims to provide capital growth by investing in equities of companies worldwide which the investment manager believes will benefit from efforts to accommodate or limit the impact of global climate change, and which meet the investment manager's sustainability criteria.

To meet these criteria, and in selecting companies in relation to climate change, the fund invests in businesses that have set targets aligned with limiting global warming to 1.5°C or less, in line with the Paris Agreement.

The fund avoids companies involved in the production of nuclear, biological, or chemical weapons, cluster munitions, depleted uranium, landmines, or white phosphorus incendiary weapons.

It also excludes companies whose revenue exceeds:

- 5% from fossil fuel extraction and production,
- 1% from the exploration, mining, extraction, or refining of hard coal or lignite,
- 30% from thermal coal power generation,
- 10% from tobacco production,
- 25% from tobacco-related activities, or
- 10% from weapons manufacturing.

In addition to these exclusions, and to support its climate change objectives, the fund avoids companies that violate the United Nations Global Compact (UNGC) principles or the Organisation for Economic Co-operation and Development (OECD) guidelines.

Furthermore, it excludes companies that derive:

- 10% or more of their revenue from oil or gaseous fuels, or
- 50% or more of their revenue from electricity generation with a greenhouse gas intensity greater than 100g CO₂e/kWh.

The value of investments within the fund may fall as well as rise, and a positive return is not guaranteed. Your child may get back less than you paid in.

Maturity

This product matures when the child reaches age 18. The recommended holding period is at least 5 years. Scottish Friendly cannot unilaterally terminate this product.

Intended retail investor

This product is intended for investors who are prepared to take on a medium level of risk, linked to the performance of the global companies who aim to benefit from efforts to accommodate or limit the impact of global Climate change, in a medium to long-term arrangement.

Insurance benefit

The amount payable on death is 101% of the value of units held within the policy.

What are the risks and what could the child get in return?

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you transfer to another provider or the child cashes in at an early stage and they may get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay the child.



We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay the child.

The product does not include any protection from future market performance so the child could lose some or all of the investment. If we are not able to pay the child what is owed, they could lose the entire investment. However, they may benefit from a consumer protection scheme (see section 'What happens if we are unable to pay you'). The indicator shown above does not consider this protection.

Performance scenarios

When money is invested it is exposed to risk, meaning that your child may get back less than was invested. The outcomes experienced will come from the returns of the investment(s) which are held by the fund. This fund invests in equities from around the world (shares in companies) therefore the performance of companies from around the world will have a significant impact on returns. Additionally the returns received could be expected to be influenced by the overall performance of the UK. It is expected, before charges, that the returns would be comparable to the UK and Global stock markets against which the performance of the fund is measured.

What could affect my return positively?

Strong economic performance, where the economy is growing around the world, this would likely lead to a positive outcome for investors. Where companies from around the world perform well resulting in their share prices increasing this would likely lead to a positive outcome.

What could affect my return negatively?

Poor economic performance also known as a recession impacting companies from around the world, resulting in falling share prices would negatively impact the returns. Under severely adverse conditions returns of the fund could be negative meaning investments in the fund could fall significantly in value. Your child's maximum loss would be that they lose all of their investment.

What happens if Scottish Friendly is unable to pay out?

If you buy a policy with Scottish Friendly and we cannot pay the full amount due, the child may be entitled to compensation under the Financial Services Compensation Scheme. The maximum level of compensation for claims against firms declared in default is 100% of the claim with no upper limit.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return the child might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself. They include potential early exit penalties. The figures assume you invest £10,000 at outset. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended minimum holding period: 5 years

This product has no minimum required holding period. It is designed to provide potential growth on investments over the medium to long term, so you should expect to leave your money invested for at least 5 years. Within the first 5 years of setting up the policy, if it is transferred by the registered contact to another Junior ISA manager, or if the child turns 18 and requests a withdrawal which would leave a value of less than £50 in their policy, there will be a £50 deduction from the child's plan.
