- These are the terms and conditions of entry into the Competition (Terms). By entering into the Competition, you are deemed to have accepted these Terms.

- 16. On such occasions, entrants will be provided with an opportunity to opt-out of receiving further marketing information. Entrants may also contact the Promoter at any time if they do not wish to receive marketing and/or promotional information.
- 17. The Promoter may, for an indefinite period, unless otherwise advised, use the information gathered by this Competition for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. Entrants should direct any request to access, update or correct information to the promoter.
- 18. For avoidance of doubt, entrants consent to the Promoter using their name, image and voice in the event they are the winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting the Competition and subsequent similar competitions.
- 19. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity and age) and to disqualify any entrant who submits an entry that is not in accordance with these Terms or who tampers with the entry process. Errors and omissions will be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.  - (b) any theft, unauthorised access or third party interference; and
- 26. (c) any entry that is late, lost, altered, damaged or misdirected (whether or not after receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter.
