

2026 Mother's Day Styling Sessions – Terms and Conditions

1. Promotion details

1.1 The 2026 Mother's Day Styling Sessions (**Promotion**) is conducted jointly by [Majura Park Retail Pty Limited ACN 109 406 680] (**Majura**) and [Just Cuts at Majura Retail] (**Just Cuts**).

1.2 The Promotion offers complimentary hair styling sessions (blow waves and heat styling only) to eligible customers at the Majura Park Shopping Centre (**Centre**).

1.3 The Promotion will run on [6, 7 & 8 May] between [11am] and [2pm], unless extended, modified or cancelled in accordance with these Terms and Conditions.

1.4 The Promotion takes place at [Majura Park food court area]

2. Nature of promotion

2.1 This Promotion is not a competition. No purchase is required to participate.

2.3 Styling sessions are provided for promotional purposes only and have no cash value.

3. Eligibility

3.1 The Promotion is open to customers of the Centre who are:

- (a) 18 years or older; and
- (b) present at the Centre during the Promotion period.

3.2 Participation is limited to one (1) styling session per person during the Promotion.

3.3 Participation is subject to availability and operating capacity.

4. Booking and availability

4.1 Styling sessions are available on a first-come, first-served basis, unless otherwise specified by the Centre or Just Cuts.

4.2 Sessions are strictly subject to stylist availability.

4.3 Just Cuts reserves the right to decline or discontinue bookings if capacity limits are reached.

4.4 No new clients will be accepted within 15 minutes of the scheduled end time of the Promotion.

5. Service limitations and stylist conditions

5.1 Styling sessions are limited to standard blow wave styling or heat styling only [no hair wash services are provided as part of this Promotion]. Each styling session is subject to a maximum duration of [30] minutes. The actual session length may be shorter and is determined at the discretion of the stylist.

5.2 The following conditions apply to all participants:

- (a) Participants must attend with clean hair that has been washed within the last two (2) days.

(b) Participants must consent to the application of hair styling products as required for the blow wave service.

(c) No special requests, advanced styling, or customised looks are available.

(d) No hair treatments (including colouring, cutting, conditioning or chemical services) will be provided.

(e) The styling session is a one-off promotional service and cannot be exchanged, repeated, or upgraded.

5.3 Just Cuts stylists may refuse or discontinue a service if, in their professional judgment:

(a) the participant's hair condition is unsuitable for the promotional service;

(b) the service would pose a safety or health risk; or

(c) the participant does not comply with these Terms and Conditions.

6. Health and safety

6.1 Participants receive styling services at their own risk.

6.2 Participants must disclose any known scalp, skin or hair conditions, allergies or sensitivities prior to the service.

6.3 To the extent permitted by law, neither the Centre nor Just Cuts accepts responsibility for any adverse reaction resulting from failure to disclose relevant information.

7. General conduct

7.1 Participants must behave respectfully toward staff, stylists and other customers.

7.2 The Centre and Just Cuts reserve the right to refuse service to any person engaging in disruptive, unsafe or inappropriate behaviour.

8. Privacy

8.1 Personal information collected in connection with the Promotion will be used for:

(a) administering the Promotion and bookings; and

(b) operational and safety purposes.

8.2 Personal information will be handled in accordance with the *Privacy Act 1988* (Cth) and applicable privacy policies of the Centre and Just Cuts.

9. Photography and marketing

9.1 Participants may be photographed or filmed during the Promotion.

9.2 By participating, participants consent to the use of their image for Centre and Just Cuts promotional and marketing purposes, without compensation, unless they advise otherwise at the time.

10. Changes and cancellation

10.1 The Centre and Just Cuts reserve the right to modify, suspend or cancel the Promotion due to operational requirements, staffing issues or circumstances beyond reasonable control.

10.2 The Centre and Just Cuts are not responsible for:

- (a) waiting times;
- (b) missed sessions due to late arrival or no-show; or
- (c) inability to service all interested participants due to demand.

10.3 No compensation will be payable if the Promotion is modified or cancelled.

11. Liability

11.1 To the extent permitted by law, the Centre and Just Cuts exclude all liability for any loss, damage or injury arising from participation in the Promotion.

12. Governing law

12.1 These Terms and Conditions are governed by the laws of the Australian Capital Territory, and participants submit to the jurisdiction of ACT courts.
