

## **FRESH FEST TERMS AND CONDITIONS OF ENTRY**

1. These Terms and Conditions apply to entry to Fresh Fest to be held at Majura Park Shopping Precinct, Car Park outside Pillow Talk retail shop on 27 June 2026 at 7 -15 Mustang Avenue, Canberra Airport ACT 2609 (**Event**). The Event commences at 10.00am and concludes at 3.00pm (or earlier if closed for capacity, safety or operational issues).
2. The Event is organised by Canberra Airport Pty Ltd ACN 080 361 548 (**Organiser**).
3. By attending the Event, you agree to be bound by these Terms and any reasonable directions given by the Event Organiser, its staff or security personnel.
4. Entry is subject to capacity limits and compliance with directions from staff or security.
5. Activities, workshops, giveaways and experiences are subject to availability and may be offered on a first come, first served basis.
6. Queues may close at any time without notice once capacity or operational limits are reached.
7. Entry to specific activities or areas is not guaranteed.
8. The Organiser reserves the right to refuse entry or eject any person from the Event at its sole discretion.
9. Children under 18 must be accompanied and supervised by a responsible adult.
10. Any items you bring to the Event (including bags, prams, strollers, and mobility aids) may be searched.
11. The following items are not permitted at the Event:
  - a. weapons or dangerous items;
  - b. illegal substances;
  - c. alcohol; and
  - d. any other items considered unsafe by the Organiser.
12. The Organiser may confiscate prohibited items.
13. While at the Event, you must:
  - a. follow all directions of staff and security;
  - b. act safely and not endanger others;
  - c. not smoke or vape; and
  - d. wear appropriate clothing and footwear.
14. Animals are not permitted, except accredited assistance animals recognised under applicable law.
15. Mobility aids, prams and strollers are permitted. Bicycles, scooters, skateboards and similar products are not permitted and must not be used or ridden at the Event.
16. The Organiser reserves the right to:

- a. change the Event program, including activities, stallholders and entertainment,
  - b. change the date, time or location of the Event;
  - c. restrict or modify access to any part of the Event; and
  - d. delay, reschedule or cancel the Event (or any part of it).
17. Activities, stallholders and program elements are subject to change and availability.
18. The Event will be photographed, filmed and recorded. By attending, you consent to the use of your image, likeness or voice for promotional and operational purposes without compensation.
19. CCTV and surveillance may be in operation. By entering the Event, you consent to video and audio recording.
20. Participation in activities is at your own risk. Certain activities may involve physical movement and may not be suitable for all participants. You are responsible for assessing whether participation is appropriate for you or any person in your care. You must comply with any additional instructions or safety requirements applicable to specific activities.
21. To the maximum extent permitted by law, the Organiser excludes liability for any loss, injury or damage suffered in connection with the Event.
