Raiders Competition for Family Pass

Trade Promotions – Games of Chance – See the Raiders Play!

These Terms and Conditions include terms that limit the Promoter's liability to you, entitle the Promoter to use your name, likeness and voice in connection with this Promotion and permit the Promoter to disclose your personal information to third parties (in accordance with the Promoter's Privacy Policy <https://www.canberraairport.com.au/privacy-policy>).

Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid. Terms and Conditions

1. Entry is open to residents of ACT and NSW aged 18 years of age and over.
2. Employees and their immediate families of the Promoter, any prize drawers and any agencies, firms or companies associated with this Promotion are ineligible to enter.
